BACKGROUND/POLICY IMPLICATIONS:

Bids from alternative electric suppliers will be received by NIMEC in the afternoon on May 3, 2012. Staff and NIMEC will present the bid options to the Village Board at the Board meeting that evening for their selection. The bids will contain several different options related to the level of renewable energy – 0%, 25%, 50% and 100% additional. In addition, the Village may take the option of doing 0% additional renewable energy for the aggregation, but allowing the supplier to sign up individual residents and small businesses for additional renewable energy. All of these options will be discussed with the Village Board prior to the Board’s selection of the alternative supplier.

Subject: Electricity Supply Contract – Municipal Aggregation

On April 19, 2012, the Village Board approved Resolution 78-12 which authorized the Northern Illinois Municipal Electric Cooperative (NIMEC) to serve as the broker for the Village in regard to obtaining bids from electricity providers for municipal aggregation.

Staff was interested in holding the bid as soon as possible to maximize the savings that Lombard residents and small businesses will realize. After an alternative supplier is selected, opt-out notices will be sent to all eligible residents and small businesses, and sufficient time must be given for response to this. Then all the accounts that did not opt out will be transferred over to the new supplier on their next meter reading date. Therefore, this process will take approximately 60 days following the date of the bid, give or take a couple weeks. Selecting a bid on May 3<sup>rd</sup> will allow residents to lower their electricity cost sooner, likely around early July. This maximizes the savings for residents by getting more of the high electricity usage summer months at a lower cost.
