SUBJECT: ORDINANCE AMENDING THE LOMBARD VILLAGE CODE IN REGARDS TO SOLICITORS AND

PEDDLERS

Attached please find information pertaining to proposed amendments to the Lombard Code in regards to peddlers and solicitors. The primary amendment to the Village Code reflects a change to the permitted hours for peddlers, commercial solicitors, and fund solicitors.

Door-to-door peddlers, commercial solicitors and fund solicitors within the Village have been the subject of numerous complaints to the Village of Lombard. Such peddlers and solicitors are licensed by the Village and subject to multiple restrictions on their activities under the Village Code. Attached, please find a registry of complaints made to the Village Clerk's office in regards to peddlers and solicitors. These complaints mark only a portion of the sum of all Village complaints regarding the practices of peddlers and fund solicitors, as they are only the notes of one division of the Village. Additional complaints regarding peddlers and solicitors have been received by the Police Department, front counter staff and communications division personnel for the Village. The log also does not represent the complaints of property owners and residents not reporting their complaints or observed violations of Code to Village personnel.

In an effort to evaluate and address the non-compliance, complaints and issues regarding door-to-door solicitors and peddlers, Village staff conducted a survey of the local regulations for solicitors in neighboring municipalities (attached). The survey revealed that other jurisdictions maintain more restrictive hours for door-to-door solicitors than the Village of Lombard. Disparities between Lombard and neighboring municipalities with respect to sales hours may make the Village of Lombard a more attractive place for commercial solicitation and peddling when compared to other neighboring localities.

Accordingly, Village staff is recommending amendment of the hours for door-to-door commercial soliciting, fund soliciting and peddling from a 9:00 p.m. end time Monday-Saturday to 7:00 p.m. This amendment has been reviewed and is supported by the Police Department. Staff recommends further restriction and this amendment to the hours for commercial solicitors, fund solicitors and peddlers for the following reasons:

- The prevention of fraud;
- The prevention of potential crime;

- Protection of the privacy of residents;
- Protection from unnecessary annoyance;
- Enforcement challenges for the Police Department in twilight or dark conditions;
- Ability of residents to see individual solicitors, badges, products or documents clearly;
- Visibility and safety of solicitors and sales people traversing neighborhoods and streets in darkened conditions;
- Resident fatigue at later hours may increase annoyance of sales interruptions, impede resident aptitude for making buying decisions and increase susceptibility to aggressive sales practices; and,
- Consistency with other neighboring jurisdictions

Note that nearly all of the complaints received by the Village of Lombard have pertained to individuals engaged in the door-to-door sales of commercial products or services. The number of complaints received regarding persons engaged in door-to-door advocacy of a particular position or cause, without commercial or fund soliciting, in the Village of Lombard have been negligible. Accordingly, the proposed amendments regarding the further restrictions to peddling and soliciting hours are proposed solely for peddlers, commercial solicitors, and fund solicitors on the following basis:

- Virtually all of the complaints received by the Village are for commercial solicitors, fund solicitors or peddlers;
- The Village has received significantly fewer complaints regarding persons engaged in door-to-door advocacy of positions or causes (without commercial or fund soliciting);
- Door-to-door advocates of positions or causes are more likely to be local Lombardians or neighbors with a local interest in the ability to advocate or communicate with neighbors;
- Commercial solicitors, fund solicitors, and peddlers are more likely to be out of area sales persons than local Lombardians or neighbors seeking to communicate with neighbors;
- Commercial solicitors are attempting financially benefit or gain for themselves or a corporation through commercial sales or fund solicitations;
- Door-to-door advocates of positions or causes are not attempting to communicate for commercial gain, but rather share their thoughts or beliefs on an issue.

Additional changes under the Ordinance increase the cost of a solicitor permit from \$25.00 to \$50.00 to more accurately reflect the cost of administration and enforcement of the permit. Additionally, the proposed Ordinance provides that solicitors will be issued and must display a photo identification badge. The issuance and requirement of a photo identification badge is recommended to assist with identification and enforcement.

ORDINANCE NO. ____

AN ORDINANCE AMENDING TITLE XI, CHAPTER 118 OF THE LOMBARD VILLAGE CODE IN REGARD TO PEDDLERS AND SOLICITORS

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That effective April 1, 2018, Title XI, Chapter 118, Section 118.03(B), of the Lombard Village Code is amended by adding the following to the end thereof:

"In this regard, a photograph of the applicant shall be taken by the Village, for use in creating a photo ID license badge to be worn by the applicant when taking action in furtherance of any license issued pursuant to this Chapter."

SECTION 2: That, effective April 1, 2018, Title XI, Chapter 118, Section 118.05 of the Lombard Village Code is amended by revising the reference to "\$25.00", as contained therein, to read "\$50.00."

SECTION 3: That, effective April 1, 2018, Title XI, Chapter 118, Section 118.08(B) of the Lombard Village Code is amended by revising the reference to "soliciting or peddling, as herein defined, prior to 9:00 a.m. or after 9:00 p.m.", as contained therein, to read as follows:

"peddling, commercial soliciting, or fund soliciting, as herein defined, prior to 9:00 a.m. or after 6:00 p.m., or other soliciting, as defined herein, prior to 9:00 a.m. or after 9:00 p.m."

- **SECTION 4:** That, effective April 1, 2018, Title XI, Chapter 118, Section 118.08(C) of the Lombard Village Code is amended to read in its entirety as follows:
 - "(C) The photo ID license badge issued by the Village shall be displayed conspicuously on the outer garment of any person engaging in peddling, commercial soliciting, or fund soliciting in the Village of Lombard, at all times while engaging in peddling, commercial soliciting or fund soliciting."
