Punky's Pub - 16 S. Park

Punky's Pub located at 16 S. Park Avenue currently holds a Class "D" liquor license. The primary purpose of the establishment is a tavern which allows the sale of alcoholic beverages together with with the sale of packaged goods. Bill & Punky's Step Up Inn Ltd. d/b/a Punky's Pub is being sold and the new the owner, Fitz's Five Leaf Clover Inc. d/b/a Punky's Irish Pub is requesting a Class "D-VG" liquor license which would allow the establishment to continue to operate as a tavern but would include the video gaming component. The sale of the business and new ownership is expected to take effect no later than June 28, 2019.

Attached is an ordinance decreasing the entry in the Class "D" liquor licenses by one to reflect the termination of the liquor license issued to Bill & Punky's Step Up Inn Ltd. d/b/a Punky's Pub and issuance of a Class "D-VG" liquor license to Fitz's Five Leaf Clover Inc. d/b/a Punky's Irish Pub upon notification of their closing but no later than noon on June 28, 2019.

The petitioner is requesting a waiver of first reading due to the timing of the closing and the Village Board's summer schedule.

ORDINANCE NO.

AN ORDINANCE AMENDING TITLE XI, CHAPTER 112, SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES AND THE CLASS "D" AND CLASS "D-VG" LIQUOR LICENSE CATEGORIES

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That, subject to the Local Liquor Control Commissioner receiving written notice that Fitz's Five Leaf Clover Inc. has acquired Punky's Pub, located at 16 S. Park Avenue, Lombard, Illinois, on or before Noon on June 28, 2019, (the "Notice"), effective with the date of said Notice, the provision of Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code, relative to the Class "D" liquor license category, is amended to read in its entirety as follows:

"Class "D" - 2"

This reduction in the number of the Class "D" liquor licenses reflects the termination of the Class "D" liquor license issued to Bill & Punky's Step Up Inn, Ltd. d/b/a Punky's Pub, located at 16 S. Park Avenue, Lombard, Illinois.

SECTION 2: That, subject to the Local Liquor Control Commissioner receiving written notice that Fitz's Five Leaf Clover, Inc. has acquired Punky's Pub, located at 16 S. Park Avenue, Lombard, Illinois, on or before Noon on June 28, 2019, (the "Notice"), effective with the date of said Notice, the provision of Title XI, Chapter 112, Section

112.13(A) of the Lombard Village Code, relative to the Class "D-VG" liquor license category, shall be amended to read in its entirety as follows:

"Class "D-VG" - 1"

This increase in the number of Class "D-VG" liquor licenses reflects the issuance of a new Class "D-VG" liquor license to Fitz's Five Leaf Clover Inc. d/b/a Punky's Irish Pub, located at 16 S. Park Avenue, Lombard, Illinois.

SECTION 3: In the event that the Notice, as referenced in Sections 1 and 2 above, is not received on or before Noon on June 28, 2019, the provisions of Sections 1 and 2 above shall be null and void; the reference to the Class "D" liquor license category in Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code shall continue to read as "Class "D - 3"; and the reference to the "Class "D-VG" liquor license category in Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code shall continue to read as, "Class "D-VG"- 0".

SECTION 4: That this Ordinance shall be in full force and effect from and after its passage and approval, as provided by law.
