The Village of Lombard's in-house paving program is conducted using Village owned equipment and rented equipment. Once paving commences and the equipment has been rented, unexpected delays in getting materials can be costly in additional days of rental charges. Dupage Material Company has been the material supplier for the Village for the last 3 years. Dupage Material has multiple locations to pick up asphalt and the material has been readily available. Other companies have had difficulty supplying asphalt in the quantities our crews need to finish a job.

Three local asphalt companies have provided quotes for binder and surface asphalt. Dupage Material provided the lowest quote for both asphalt binder and surface.
