One (1) 125kW natural gas driven generator in an amount not to exceed \$36,530.00

One (1) 300kW diesel driven generator in an amount not to exceed \$78,735.00

 - a. The Contractor's Quote Dated July 3, 2019
 - b. Required Certificate of Insurance, Indemnification, Venue, Other Contractor Responsibilities
- 2. The Village agrees to pay, and the Contractor agrees to accept as full payment for the items which are the subject matter of this Contract the total sum of \$115,265.00 paid in accordance with the provisions of the Local Government Prompt Payment Act and the provisions of the Contract Documents.
- 3. Risk of loss, destruction or damage of or to goods under this Contract shall be on contractor until delivery of the goods to the Village and acceptance of the goods by the Village.
- 4. The Contractor agrees to perform the terms of this Contract according to the following schedule: Deliver submittals for Village approval within one (1) week of Notice to Proceed and deliver equipment within ten (10) weeks from the date the Village approves the submittals. Time is of the essence of this Contract.
- 5. Where the terms of this Contract conflict with the provisions of the Contract

 Documents, the Contract Documents shall be binding.
