SUBJECT: Residential Refuse Collection Rate Increase Due to State Gas Tax

DATE: September 12, 2019

Attached is a proposed ordinance to increase the monthly residential account fees. Waste Management has requested this as their right per the Solid Waste Contract following the State gas tax increase. Please present the ordinance to the Board of Trustees at their September 19, 2019 meeting. The increase would take effect on October 1, 2019.

BACKGROUND:

State of Illinois Public Act 101-0032 increased the gas tax by \$0.19 for CNG and \$0.23/gallon for diesel in DuPage County as of July 1, 2019. Waste Management has provided calculations substantiating increased costs for each residential account by \$0.11/month. The new monthly collection fees will be \$14.98 for the standard 64-gallon toter, and \$12.05 and \$18.07 for the 35-gallon and 96-gallon sizes, respectively.

The pertinent clause in the Solid Waste Contract is:

Section 29D. Changes in Law.

Notwithstanding anything in this **Contract** to the contrary, **Contractor** may request an adjustment to the rates set forth herein to account for increased costs due to changes in local, State or Federal laws or regulations, imposing increases in taxes, fees or surcharges directly assessed on the **Refuse**, **Recyclables** and **Yard Waste** collection services by the Federal, State, County, or local government. The method of distributing such costs among the customer base shall be mutually agreed by **Contractor** and **Village**.

The attached draft ordinance amending the Lombard Municipal Code § 92.17has been reviewed by the Village Attorney. Similar to the annual CPI fee adjustments, this matter may be presented directly to the Board.

RECOMMENDATION:

Staff recommends that the Board of Trustees approve the Ordinance.

ORDINANCE NO.

AN ORDINANCE AMENDING TITLE IX, CHAPTER 92, SECTION 92.17 OF THE LOMBARD VILLAGE CODE IN REGARD TO WASTE COLLECTION AND DISPOSAL FEES

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That, effective October 1, 2019, Title IX, Chapter 92, Section 92.17 of the Lombard Village Code is amended as follows:

- A. The reference to "April 1, 2019", in the opening language of subsection (A), is revised to read "October 1, 2019."
- B. Subsections (A)(1), (2), and (3) are revised to read in their entirety as follows:
- "(1) Pick up of one (1) thirty-five (35) gallon Cart Waste Container and an unlimited amount of Recyclables (as defined by the Village's Contract with the authorized Waste Disposal Firm) at the curb; \$12.05 per month.
- (2) Pick up of one (1) sixty-four (64) gallon Cart Waste Container and an unlimited amount of Recyclables (as defined by the Village's Contract with the authorized Waste Disposal Firm) at the curb; \$14.98 per month.
- (3) Pick up of one (1) ninety-six (96) gallon Cart Waste Container and an unlimited amount of Recyclables (as defined by the Village's Contract with the authorized Waste Disposal Firm) at the curb; \$18.07 per month."
 - C. Subsection (G) is amended to read in its entirety as follows:
- "(G) The rates listed in this Section 92.17 shall be in full force and effect as of October 1, 2019, and shall be subject to annual adjustment thereafter, on April 1st of each year, in accordance with Sections 29A, 29B and 29C of the Solid Waste Collection and Disposal Services Contract approved by the President and Board of Trustees on January 7, 2016, as amended by the First Amendment to Solid Waste Collection and Disposal Services Contract dated April 5, 2018, the Second Amendment to Solid Waste Collection and Disposal Services Contract dated October 18, 2018, and the Third Amendment to the Solid Waste Collection and Disposal Services Contract dated September 5, 2019 (collectively referred to above, in this Section, as the "Contract")."

SECTION 2: That this Ordinance shall be in full force and effect on from and after its adoption, approval and publication in pamphlet form as provided by law.

Dear Dave,

Thank you for your business. We are committed to providing you safe, reliable and environmentally sound waste and recycling services that meet your highest expectations.

Effective July 1, 2019, the State of Illinois implemented a fuel tax increase to provide long-term and sustainable funding for the local and state transportation infrastructure. Pursuant to our agreement, we are requesting an increase in the service rate to reflect the new taxes on our cost to service the community. The monthly rate per home will increase \$0.11 per month effective October 1, 2019. This coincides with our billing to the residents.

As outlined on the attached document, we have carefully reviewed the cost impact in every area this new tax impacts our cost. There is our best estimate per home and is intended to cover only the cost increase as a result of the tax.

We calculated this cost increase with the assistance of a third-party accounting firm Deloitte and Touche. The specifics of this tax language are as follows:

To fund road infrastructures in the state, the General Assembly passed SB 1939 (Sandoval, D - Cicero) to double the motor fuel taxes and earmarks this money to be placed in a dedicated fund (historically motor fuel taxes were part of the General Fund and were appropriated for road construction).

Effective July 1, 2019, the legislation will increase the motor fuel tax from 19 cents to 38 cents, and is adjusted annually per the CPI. In addition, diesel fuel and other "special fuels" (LNG and propane) are subject to an additional tax of 5.0 cents per gallon. CNG is taxed as motor fuel under state law. The total cost increase is 24.0 cents per gallon in Cook County and 23.0 cents per gallon in Lake, Will, DuPage, Kane, and McHenry Counties. The legislation will also increase all categories of trucks registration fees by \$100.

- Compressed natural gas (CNG) is taxed at the same rate as gasoline. Effective July 1, 2019, the tax rate on gasoline and CNG will be 38 cents per gallon. Effective July 1, 2019, a vehicle that is fueled by diesel, liquified natural gas (LNG) or propane will pay an additional 7.5 cents per gallon. Therefore, effective July 1, 2019 the total motor fuel tax on a gallon of diesel, LNG or propane will be 45.5 cents per gallon.
- Adjusted for inflation annually Beginning June 1, 2020, and every June thereafter, the tax rate is adjusted for inflation. *** However, the rate increase cannot exceed 1 cent over the prior year tax rate.
- Truck registration fees are increased by \$100 in all classes and categories.
