## AN ORDINANCE GRANTING APPROVAL OF CONDITIONAL USE PURSUANT TO SECTION 155.420(C)(23) OF THE VILLAGE CODE FOR MOTOR VEHICLE SERVICE LOCATED IN THE I ZONING DISTRICT

#### PC 19-10: 948 N. Ridge Avenue

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore adopted the Lombard Zoning Ordinance, otherwise known as Title 15, Chapter 155 of the Code of Lombard, Illinois;

WHEREAS, the Subject Property as defined below is zoned I; and,

WHEREAS, an application requests approval for a conditional use for a motor vehicle service establishment; and,

WHEREAS, a public hearing on such application has been conducted by the Village of Lombard Plan Commission on May 20, 2019 pursuant to appropriate and legal notice; and,

WHEREAS, the Plan Commission has filed its recommendations with the President and Board of Trustees recommending approval of the conditional use described herein; and,

WHEREAS, the President and Board of Trustees approve and adopt the findings and recommendations of the Plan Commission and incorporate such findings and recommendations herein by reference as if they were fully set forth herein;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

SECTION 1: That a conditional use is hereby granted for the Subject Property, as described in Section 4 below, pursuant to Title 15, Chapter 155, Section 155.420(C)(23) of the Village Code for a motor vehicle service establishment;

SECTION 2: This ordinance is limited and restricted to the property generally located at 948 N. Ridge Avenue, Lombard, Illinois, and legally described as follows:

LOT 6 IN W. E. ERICKSON CONSTRUCTION SUBDIVISION OF PART OF THE SOUTHEAST ¼ OF SECTION 31, TOWNSHIP 40 NORTH, RANGE 11, EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED APRIL 11, 1978 AS DOCUMENT R78-29602, IN DUPAGE COUNTY, ILLINOIS.

SECTION 3: The approvals set forth in SECTION 1 above shall be granted subject to compliance with the following conditions:

- 1. That the petitioner shall satisfactorily address all comments noted within the Inter-Departmental Review Committee Report;
- 2. All motor vehicle service activities shall be done within the enclosed building;
- 3. All parts and components of the service activities shall be stored within the enclosed building; and
- 4. All parking on-site of vehicles being serviced shall be accommodated in designated parking spaces and will remain fully assembled while parked outside.

SECTION 5: This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.
