Subject: Sanitary Sewer Overflow Investigation Engineering Services

Attached are a contract, resolution, and fee schedule for engineering services related to the Sanitary Sewer Overflow Investigation Program. This firm was selected from a request for proposals sent to the five firms on the current Design Engineering Shortlist, plus RJN Group of Wheaton since they specialize in this type of work. A total of three proposals were received.

Background

Public Works wishes to reduce sanitary sewer overflows in two areas during moderate to heavy storm events. The first area is on the east side of Route 53. The manhole that overflows is located at the dead-end of Phillips Court. The second area is the north and east sides of Terrace View Pond, where two structures on West Berkshire Avenue periodically overflow, and a third structure at the intersection of Park and Crystal Avenues nearly overflows. The selected firm will comprehensively investigate the tributary sanitary sewer system. The scope of work includes flow monitoring (over many months or until an overflow event, whatever occurs first), obtaining GPS data for the sanitary manholes, televising the sanitary sewers and manholes, smoke testing, and possibly dye testing of the adjacent storm sewers.

The sewer and manhole conditions will be recorded in the Asset Management system. After analysis, projects that address the sewerage deficiencies will be identified. Budget estimates for these projects will then be programmed into the Capital Improvement Program (CIP).

Award

Staff's four-person evaluation committee selected Baxter & Woodman of Crystal Lake as the "most qualified" firm. Baxter & Woodman (B&W) has provided engineering services for many successful Village projects.

The scope and fee were negotiated with B&W, and agreed to by both parties. The not-to-exceed fee for engineering services is \$176,031.00. Monies shall be drawn from the related CIP maintenance programs.

Please present this contract to the President and Board of Trustees at their regular meeting of May 21, 2020. If approved, please return one original signed copy to Public Works-Engineering for further processing.
