Non-Renewal of Liquor License/No Longer Conducting Business
203 Yorktown C1

Yorkville Tap, LLC d/b/a Tapville – Drink While You Shop, holds a Class “VVV” liquor license. In accordance with Village Code, liquor licenses are renewed on a semi-annual basis. Village staff completed the renewal process for the January 1 through June 30, 2026 licensing term. During the renewal process, the licensee did not submit a renewal and Village staff realized the licensee is no longer conducting business at 203 Yorktown, C1, after receipt of returned certified correspondence.

Attached is an Ordinance reflecting the decrease in the Class “VVV” Liquor License category by one (1) and terminating the liquor license issued to Yorkville Tap, LLC d/b/a Tapville – Drink While You Shop, located at 203 Yorktown C1, pursuant to Title XI, Chapter 112, Sections, 1127.17 and 112.27 of the Lombard Village Code.

Staff is requesting a waiver of first reading in order to bring the number of entries in the Liquor License Class “VVV” current. Please place this item on the February 5, 2026, Village Board of Trustees agenda for consideration.

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112,
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE TO REDUCE THE NUMBER
OF AVAILABLE LIQUOR LICENSES IN THE
CLASS “VVV” LIQUOR LICENSE CATEGORY**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

SECTION 1: That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class “VVV” liquor licenses, contained therein, to read as follows:

Class “VVV” – 0

SECTION 2: That the decrease in the number of Class “VVV” liquor licenses as set forth in Sections 1 above is a result of Yorkville Tap, LLC d/b/a Tapville – Drink While You Shop, non-renewal of liquor license for the January 1, 2026 – June 30, 2026 licensing term and no longer conducting business at 203 Yorktown, C1, Lombard, IL 60148.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
