DuPage County Health Department Gravid Trap Assistance

The attached letter from the DuPage County Health Department confirms their offer to operate 4 Gravid Traps in Lombard during the 2004 mosquito season. The Gravid Traps attract Culex mosquitoes, which are carriers of the West Nile Virus.

There was no quorum for the last Environmental Concerns Committee. I was asked to poll the Committee to see if they would be willing to accept the 4 Gravid Traps. The Committee unanimously agreed the Village should accept the traps. This service offered by the County free of charge will be good for our mosquito abatement program because we had to pay \$24,000 last year for the same service provided by our contractor.

The Environmental Concerns Committee had requested an explanation of what the County meant by "maintaining initially 4 Gravid Traps" (see attached letter from the Health Department).

I called Thaddeus Koeune at the DuPage County Health Department for an answer. Mr. Koeune said the County will provide 4 Gravid Traps in Lombard as promised. They will not remove any traps. In fact, they may even add traps if the surveillance shows this is warranted. They may move the traps from place to place in Lombard based on the results of the trapping.

Mr. Koeune's final comment was that he wanted to reassure us that Lombard will receive a minimum of 4 Gravid Traps during the 2004 mosquito season.
