The FY 2006 budget includes replacement of SM444, a 2000 4x4 pick-up with plow. The bid results are as follows:

Public Works received four sealed bids. Freeway Ford was low bidder. The bid price for the 2006 4x4 pick-up with plow is \$25,645 less a trade-in allowance of \$8,250 equals a net total bid of \$17,395. The budgeted amount is \$19,500.
