Beverages - Bricks Wood Fired Pizza Cafe - 2770 S. Highland Avenue

Decrease Class "C" Liquor License

Licensee Bricks on Highland, LLC d/b/a Bricks Wood Fired Pizza Café, located at 2770 S. Highland, Avenue, currently holds a Class "C" liquor license.

On October 7, 2025, Village staff were (formally) notified of a change in ownership interests within the LLC. Specifically, 33% of the ownership interest of one of the three most recent (effective July 2020) owners was sold to two existing owners and one new owner, effective December 31, 2024.

Pursuant to Village Code Title XI, Chapter 112, Section 112.20(D), a liquor license shall terminate whenever 50 percent or more of the ownership interest changes from that shown on the original license application. Because the entity previously modified its ownership structure in July 2020, this latest transaction results in a cumulative ownership change exceeding the 50% threshold, thereby terminating the current Class "C" liquor license.

The licensee has informed Village staff that they will not be submitting a new application for a new Class "C" liquor license. All alcoholic liquor was removed from the premises as of October 22, 2025.

Attached is an ordinance decreasing the number of Class "C" licenses by one to reflect the correct number of licenses.

Staff is requesting a waiver of first reading to reflect these changes.

ORDINANCE

AN ORDINANCE AMENDING TITLE XI, CHAPTER 112, SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE TO REDUCE THE NUMBER OF AVAILABLE LIQUOR LICENSES IN THE CLASS "C" LIQUOR LICENSE CATEGORY

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

<u>SECTION 1:</u> That, Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by decreasing the entries relative to the Class "C" liquor licenses, contained therein, to read as follows:

Class "C" - 7

<u>SECTION 2</u>: That, the decrease in the number of Class "C" liquor licenses set forth in Section 1 above is a result of Bricks on Highland, LLC d/b/a Bricks Wood Fired Pizza Cafe, 2770 S. Highland Avenue, license terminating due to a change of 50 percent or more in ownership and voluntarily not applying for a new license for the remainder of the July 1 through December 31, 2025, liquor licensing term.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
