**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112,
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE TO INCREASE THE NUMBER
OF AVAILABLE LIQUOR LICENSES IN THE CLASS
"C" LIQUOR LICENSE CATEGORY**

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by increasing the entries relative to the Class "C" liquor license category, to read as follows:

"C" – 8"

SECTION 2: That, the increase in the number of Class "C" liquor licenses set forth in Section 1 above reflects the issuance of a new Class "C" liquor license to Bricks on Highland, LLC d/b/a Bricks Wood Fired Pizza Cafe, located at 2770 S. Highland Avenue for the remainder of the July 1, 2025 – December 31, 2025, license term.

SECTION 3: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.


