**SUBJECT: Text Amendment to Title 11, Chapter 121, Section 121.03A.(2)
Number of Public Passenger Licenses**

Holiday Taxi & Limo located at 6714 High Road, Darien, submitted a renewal application and documentation to renew their taxicab business license for the business license renewal period July 1, 2013 through June 30, 2014. Holiday Taxi & Limo has not met the criteria of being in good standing with the Secretary of State's Office and consequently, the Village of Lombard cannot renew their taxicab license. Staff has made repeated attempts to contact the applicant in order to resolve the situation. As of this writing, we have had no reply.

Attached is an ordinance amending Title 11, Chapter 112, Section 121.03A.(2) decreasing the number of Public Passenger Licenses from eleven to ten.

Staff is requesting a waiver of first reading in order to reflect the current number of public passenger licenses.

As you are aware, on October 21, 2013 we sent you a letter requesting that you contact me regarding the disposition of your Taxicab Business License Renewal Application (see copy attached).


Since I have not received a reply as of this writing, the Village of Lombard has interpreted your lack of response to mean that you are not desirous of renewing your Taxicab Business License in the Village of Lombard. Consequently, this letter is to advise that your Taxicab Business License is expired and according to Lombard Village Code, it is unlawful to operate within the Village of Lombard. This means that while you are allowed to drop off a fare, you are not allowed to pick up a fare within the corporate limits of the Village of Lombard. If you do and get caught, you could be issued a citation of up to \$750.00.

Enclosed find Village of Lombard check #4204 in the amount of \$250.00 refunding your application fee. Further, be advised that the Lombard Village Board, at the December 19, 2013 meeting, will vote on decreasing the number of taxicab business licenses by one to reflect the expiration of your license.

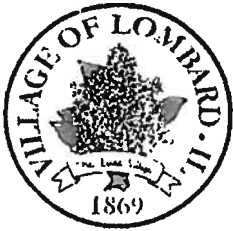

Dear Mr. Metcalf:

Holiday Taxi & Limo Service submitted a renewal application and required documentation, as well as payment in the amount of \$250.00, in order to secure a Taxicab Business License in the Village of Lombard.

In order to receive any business license in the Village of Lombard, a number of factors need to be met. Beside the items listed above your corporation must be in good standing with the Illinois Secretary of State's Office.

I have left telephone messages, and sent correspondence, notifying you that your corporation, "Holiday Taxi & Limo Service", is not in good standing with the Illinois Secretary of State's Office, and consequently, we cannot issue a Taxicab Business License to your corporation. According to the Lombard Village Code, in order to provide Taxicab service in the Village of Lombard, you must secure a business license prior to commencing such services.


In an effort to remedy the situation, we offer the following:

- We can refund your \$250.00, with the understanding you are not allowed to provide Taxicab service within the Village of Lombard; or.
- You can return to the Village Hall, to complete paperwork that lists you personally, and not the corporation, as the business entity. We could then issue the license to you personally.

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 121,
SECTION 121.03 OF THE LOMBARD VILLAGE CODE IN
REGARD TO PUBLIC PASSENGER LICENSES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 121, Section 121.03A.(2) of the Lombard Village Code is amended to read as follows:

(2) Number

There shall be ~~eleven (11)~~ ten (10) Business Licenses issued by the Village. No additional Business Licenses shall be issued unless approved by the Board of Trustees.

Section 2: That the change in the number of Public Passenger Licenses set forth in Section 1 above, is a result of the non-renewal of the license by Holiday Taxi & Limo Service located at 6714 High Road, Darien, Illinois.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
