Staff is requesting a waiver of first reading in order to bring the number of licenses in this liquor license category current.

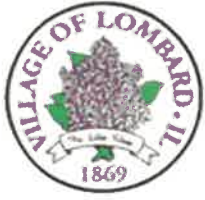

**SUBJECT:** **Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code  
Alcoholic Beverages  
Voluntary Non-Renewal of Liquor License**

In accordance with Village Code, liquor licenses are renewed on a semi-annual basis and the Village is currently in the January 1 – June 30, 2025, licensing term. The owner of Billy Goat Tavern West, LLC d/b/a Billy Goat Tavern & Grill, located at 203 Yorktown Shopping Center, notified the Village staff that the licensee will voluntarily not renew their liquor license for the current licensing term, with a last day of sales for alcohol effective, December 31, 2024.

Attached is an ordinance decreasing the number of entries in the “A/B-I” liquor license classification by one, effective January 1, 2025, to account for their voluntary non-renewal.

Staff is requesting a waiver of first reading in order to bring the number of entries in the A/B-I liquor classification current.

**ORDINANCE**

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112,  
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE TO REDUCE THE  
NUMBER OF AVAILABLE LIQUOR LICENSES IN THE CLASS  
“A/B-I” LIQUOR LICENSE CATEGORY**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF  
THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

**SECTION 1:** That, effective January 1, 2025, Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by decreasing the entries relative to the Class “A/B-I” liquor licenses, contained therein, to read as follows:

Class “A/B-I” – 4

**SECTION 2:** That, effective January 1, 2025, the decrease in the number of Class “A/B-I” liquor licenses set forth in Section 1 above is a result of Billy Goat Tavern West, LLC d/b/a Billy Goat Tavern & Grill, 203 Yorktown Shopping Center, voluntarily not renewing their liquor license for the January 1 through June 30, 2025, liquor licensing term.

**SECTION 3:** This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
