We listened to a presentation from Public Works Director Carl Goldsmith about allowing overnight parking in the East St. Charles Commuter Lot, subject to certain rules and restrictions. After consulting with public works and the police department, the committee voted unanimously to recommend this for future Board consideration. We heard monthly recaps from the fire and police department. I am excited to share that, after a revamping of our fire department recruitment plan, we currently have 225 qualified applicants hoping to join our Lombard Fire Department. That is a really impressive number and a testament to how great our fire department is.
