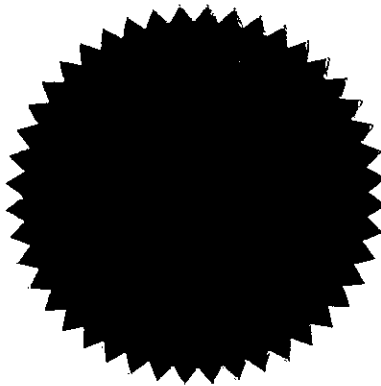

AN ORDINANCE
REPEALING ORDINANCE NO. 5160, ADOPTED JUNE 20, 2002,
AMENDING ORDINANCE NO. 5195, ADOPTED SEPTEMBER 5, 2002
AND ANNEXING CERTAIN PROPERTIES
BY THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS

(BOT 02-20: 2N119, 2N133, 2N109, 2N081, 2N063,
2N041 Route 53 and 448 W. North Avenue)

WHEREAS, on the 20th of June, 2002, the President and Board of Trustees of the Village of Lombard have heretofore adopted Ordinance No. 5160, approving the annexation of 2N119, 2N133, 2N109, 2N081, 2N063, and 2N041 Route 53 and 448 W. North Avenue, Lombard, Illinois; and,

WHEREAS, on the 5th of September, 2002, the President and Board of Trustees of the Village of Lombard have heretofore adopted Ordinance No. 5195, re-approving the annexation of 21W035 North Avenue, 1N744 Route 53, and 640 N. Route 53, Lombard, Illinois, pursuant to appropriate and legal notice; and,

WHEREAS, said Ordinance also re-approved the annexation of 2N119, 2N133, 2N109, 2N081, 2N063, and 2N041 Route 53 and 448 W. North Avenue, Lombard, Illinois; and,

WHEREAS, the President and Board of Trustees find that the legal description in Ordinance No. 5160 and the associated reference included within Ordinance No. 5195 incorrectly legally described the subject property; and

WHEREAS, the President and Board of Trustees find it necessary and proper to provide appropriate and legal notice pursuant to State Statutes; and

WHEREAS, the following described unincorporated territory is completely surrounded by the Village of Lombard; and

WHEREAS, the following described unincorporated territory is comprised of less than sixty (60) acres of land area; and

WHEREAS, the Village of Lombard desires to annex the following described unincorporated territory pursuant to 65 ILCS 5/7-1-13; and

WHEREAS, notice of said contemplated annexation was published in the Spectator newspaper on May 17, 2002, said newspaper being a newspaper of general circulation within the territory to be annexed; a copy of the Publisher's Certificate relative to said publication being attached hereto as Exhibit "A", and made part hereof; and

WHEREAS, written notice of said contemplated annexation was sent by certified mail, return receipt requested, to each Trustee of the Addison Fire Protection District, the Addison Township Highway Commissioner, each member of the Board of Trustees of Addison Township and each property owner within the territory; an Affidavit of Service relative to said notice being attached hereto as Exhibit "B", and made part hereof; and the return receipt cards being attached hereto as Exhibit "C", and made part hereof; and

WHEREAS, all necessary legal requirements are in full compliance with the terms of 65 ILCS 5/7-1-13; and

WHEREAS, it is in the best interest of the Village of Lombard that the following described unincorporated territory be annexed thereto;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: The Village of Lombard hereby repeals Ordinance No. 5160 in its entirety.

SECTION 2: The Village of Lombard hereby amends SECTION 1 of Ordinance 5195 to read as follows:

SECTION 1: That the Village of Lombard readopts Ordinances-5159 and 5160 in their entirety.

SECTION 3: That all other provisions of Ordinance 5195 shall remain in full force and effect.

SECTION 4: That the following described territory:

LOT 1 IN MEYER CONSOLIDATION PLAT OF THE EAST HALF OF LOTS 6 & 7 IN
GAUGER'S ASSESSMENT PLAT OF THE SOUTHWEST QUARTER OF THE
SOUTHWEST QUARTER OF SECTION 31, TOWNSHIP 40 NORTH, RANGE 11
EAST OF THE THIRD PRINCIPAL MERIDIAN ACCORDING TO THE PLAT
THEREOF RECORDED FEBRUARY 12, 1997 AS DOCUMENT R97-21278,
ALSO;
THE EAST 338.47 FEET OF LOT 2 AS MEASURED ALONG THE NORTH AND
SOUTH LINES THEREOF, THE WEST 264.00 FEET OF LOT 2 AS MEASURED
ALONG THE NORTH LINE THEREOF, THE EAST 338.47 FEET OF LOT 3 AS
MEASURED ALONG THE NORTH AND SOUTH LINES THEREOF, THE WEST
381.23' OF LOT 4 AS MEASURED ALONG THE NORTH AND SOUTH LINES
THEREOF, THE WEST HALF OF LOTS 6 AND 7 AND ALL OF LOT 5, IN
GAUGER'S ASSESSMENT PLAT, OF PART OF THE SOUTHWEST QUARTER OF
THE SOUTHWEST QUARTER OF SECTION 31, TOWNSHIP 40 NORTH, RANGE 11
EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT
THEREOF RECORDED AUGUST 13, 1946 AS DOCUMENT 504356, IN DU PAGE
COUNTY, ILLINOIS.

SECTION 5: The Village Clerk is hereby directed to record with the Recorder and file with the County Clerk a certified copy of this Ordinance, together with all Exhibits attached hereto.

SECTION 6: The Village Clerk is hereby directed to give written notice of this annexation, by certified mail return receipt requested, to the election authority having jurisdiction in the annexed territory and to the post office branches serving the annexed territory.

SECTION 7: The Village Clerk is hereby directed to record with the Recorder of Deeds and to file with the County Clerk, a certified copy of this Ordinance, and the original Plat of Annexation.

SECTION 8: This ordinance shall be in full force and effect from and after its passage and approval as provided by law.
