Attached is the contract for construction of the 22nd Street Manhole Improvements Project.

Background

The 22nd Street Manhole Improvements (Junction Chamber) is a project included within the Village's current Capital Improvement Program. The CIP budget for this project was \$300,000. The Village will be receiving funds from the Rebuild Illinois Capital Plan in the amount of \$200,000 and the Village will cover the remaining balance from the Water and Sewer Capital Reserve Budget.

The Village awarded a contract in April of 2019 for the South Lombard Sanitary Force Main Relief Sewer Study to complete an analysis of the capacity and flow characteristics of the Yorktown Lift Station Sanitary Sewer Force Main, the New Yorktown Commons Lift Station Sanitary Sewer Force Main, and the 22nd Street gravity sanitary sewer that the force mains dump into. This study was done due to the sanitary sewer backups occurring in the Foxworth Subdivision, the increased flow of sanitary sewer from the multi-family developments on the south side of Lombard, as well as high levels of flow in the gravity sewer.

The study resulted in recommendations that included improvements to the 22nd Street Junction Chamber where the force mains tie into the gravity sewer. In November of 2022, the Village awarded a contract for the design engineering for the 22nd Street Manhole Improvements.

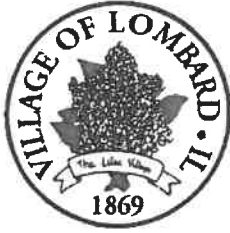
Award

The Project was bid online via QuestCDN on August 24, 2023. The Village reached out to 8 contractors that have experience working in the Village and have proven to be qualified in projects of similar size, scope, and complexity. The bid opening occurred on Monday, September 11, 2023 at 2pm. Four contractors picked up plan sets and two bids were received for this project.

John Neri Construction Co., Inc.	\$258,700.00
A Lamp Concrete Contractors, Inc.	\$354,965.25

The low bid was John Neri Construction Co., Inc. of Addison, IL in the amount of \$258,700.00. Project financing is through the Water and Sewer Capital Reserve Budget.

VILLAGE OF LOMBARD CONTRACT

CONTRACT DOCUMENT NUMBER SS 21 11

This agreement is made this 21st day of September 2023, between and shall be binding upon the Village of Lombard, an Illinois municipal corporation (hereinafter referred to as the "Village") and John Neri Construction Co., Inc. (hereinafter referred to as the "Contractor") and their respective successors.

Witnessed, that in consideration of the mutual promises of the parties delineated in the Contract Documents, the Contractor agrees to perform the services and the Village agrees to pay for the following services as set forth in the Contract Documents:

“22nd Street Junction Chamber” The project consists of installing 2 new, sanitary manhole structures, removing 1 sanitary manhole structure, installing approximately 50 lineal feet of 16-inch ductile iron force main, installing approximately 20 lineal feet of 18-inch PVC sanitary sewer, providing temporary bypass pumping, traffic control in Village ROW for 22nd Street and Highland Avenue, surface restoration, and other miscellaneous items necessary for a complete project. All of the above, as well as other project details, are further described in the contract documents for the said work prepared for the Village of Lombard by Baxter & Woodman, Inc. The project will be funded in part by the Rebuild Illinois Program administered by the Illinois Department of Commerce & Economic Opportunity. As part of this funding, the project must comply with the Steel Products Procurement Act, Federal Prevailing Wages, and Employment of Illinois Workers on Public Works Act. This work shall be performed for the not to exceed the contract price of \$258,700.00.

1. This contract shall embrace and include all of the applicable Contract Documents listed below as if attached hereto or repeated herein:
 - a. Contract Document Number SS 21 11 for 22nd Street Junction Chamber Improvements, consisting of the following:
 - i) Cover Sheet
 - ii) Table of Contents
 - iii) General Provisions
 - iv) Special Provisions
 - v) Plans and Specifications
 - vi) Addenda #1, dated September 7, 2023
 - b. The Contractor's Bid Proposal Dated: September 11, 2023
 - c. Required Performance and Payment Bonds and Certificate(s) of Insurance
 - d. Executed Bidder's Certification Form.
2. The Village agrees to pay, and the Contractor agrees to accept as full payment the amount as shown on the Contractor's Bid Proposal, which is made a part hereof, subject to such additions and deletions as agreed to by the parties hereto.
3. The Contractor shall commence work under this Contract upon written Notice to Proceed from the Village and shall fully complete work under this Contract within 90 calendar days from the date of the Notice to Proceed. Time is of the essence regarding this Contract, and the Contractor agrees to achieve completion within the time permitted by all proper and appropriate means including working overtime without additional compensation.

- 4. According to the provisions of Section 5 of the Mechanics' Lien Act of Illinois, before making any payment to the Contractor under this Contract, the Village demands that the Contractor furnish a written statement of the names of all parties furnishing labor and/or materials under this Contract and the amounts due or to become due each. This statement must be made under oath or be verified by affidavit. The Village shall not issue final payment nor shall any retained percentage become due until releases and waivers of lien have been supplied as the Village designates.
- 5. This Contract represents the entire agreement between the parties and may not be modified without the written approval of both parties.

IN WITNESS WHEREOF, the Village of Lombard, Illinois, and the Contractor have each hereunto caused this Contract to be executed by their respective duly authorized representatives on this 21st day of September 2023.

**VILLAGE OF LOMBARD
CONTRACT BOND**

KNOW ALL MEN BY THESE PRESENTS, that we _____, a company organized under the laws of the State of _____ and licensed to do business in the State of Illinois as Principal, and _____, a corporation organized and existing under the laws of the State of _____, with authority to do business in the State of Illinois, as Surety, are now held and firmly bound unto the Village of Lombard, State of Illinois in the penal sum of _____ dollars (\$ _____) lawful money of the United States, well and truly to be paid unto said Village for the payment of which we bind ourselves, our successors and assigns, jointly, severally, and firmly by these presents.

THE CONDITION OF THE FOREGOING OBLIGATION IS SUCH that whereas the said Principal has entered into a written contract with the Village of Lombard, acting through the President and Board of Trustees of said Village, dated September 21, 2023, for the construction of the work designated:

22ND STREET JUNCTION CHAMBER

in Lombard, Illinois, which contract is hereby referred to and made a part hereof as if written herein at length, and whereby the said Principal has promised and agreed to perform said work in accordance with the terms of said contract, and has promised to pay all sums of money due for any labor, materials, apparatus, fixtures or machinery furnished to such Principal for the purpose of performing such work, and has further agreed to guaranty and maintain said work for a one (1) year period following final payment to such Principal, and has further agreed to pay all direct and indirect damages to any person, firm, company, or corporation suffered or sustained on account of the performance of such work during the time thereof and until such work is completed and accepted; and has further agreed that this bond shall inure to the benefit of any person, firm, company or corporation from whom any such labor, materials, apparatus, fixtures or machinery was so furnished and that suit may be maintained on such bond by any such person, firm, company or corporation for the recovery of any such money.

NOW, THEREFORE, if the said Principal shall well and truly perform said work in accordance with the terms of said contract and shall pay all sums of money due or to become due for any labor, materials, apparatus, fixtures or machinery furnished to him for the purpose of constructing such work and shall commence and complete the work within the time prescribed in said contract, and shall pay and discharge all damages, direct and indirect, that may be suffered or sustained on account of such work during the time of the performance thereof and until the said work shall have been accepted, and shall hold the Village of Lombard and its officers, agents and employees, harmless on account of any such damages, and shall in all respects fully and faithfully comply with all the provisions, conditions, and requirements of said contract, then upon the final payment by the Village to said Principal under said contract, the amount of this bond shall be reduced to ten percent (10%) of the amount set forth on the first page hereof for a period of one (1) year; otherwise to remain in full force and effect.

NOW, THEREFORE, if the said Principal shall well and truly perform said guaranty and maintenance work in accordance with the terms of said contract for said one (1) year period after final payment and shall pay all sums of money due or to become due for any labor, materials, apparatus, fixtures or machinery furnished to him for the purpose of performing such guaranty and maintenance work and shall commence and complete the guaranty and maintenance work within the time prescribed in said contract, and shall pay and discharge all damages, direct and indirect, that may be suffered or sustained on account of such guaranty and maintenance work during the time of the performance thereof and until the said guaranty and maintenance work shall have been accepted, and shall hold the Village of Lombard and its officers, agents and employees, harmless on account of any such damages, and shall in all respects fully and faithfully comply with all the provisions, conditions, and requirements of said contract, then this obligation to be void; otherwise to remain in full force and effect.

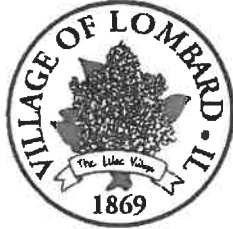
