Subject: FY23 Vehicle Purchase – Haggerty Ford

The fiscal year 2023 budget includes replacement of several village vehicles. The current conditions in the new vehicle marketplace have made securing these vehicles for purchase difficult. High market demand and low manufacturer production have culminated in low dealer

inventory and long lead times on orders resulting in higher vehicle purchase prices. In addition to these challenging marketplace conditions, vehicle manufactures have eliminated government incentives on pricing. Additionally, some of the vehicles included in the FY 2023 replacement are Ford Transit Connects. Ford along with every other manufacturer have discontinued production of these compact cargo vans which fill an important and unique role in the village fleet. This has made any remaining new inventory of the Transit Connects very hard to find and

if located, they are commanding a premium price in this market.

Public Works has been searching local dealers to source FY 2023 replacement vehicles and have located several vehicles available through Haggerty Ford in West Chicago. A quotation was provided for the following vehicles:

The unexpected market conditions have resulted in a shortfall of \$42,217 to purchase these six vehicles based on the amount of money set aside in the Fleet Reserve Fund and the anticipated salvage value for each vehicle being replaced. In addition to receiving more for the sale of the salvage vehicles, the Ford E-Transit for the water department is to be reimbursed by a grant to purchase an all-electric vehicle the Village was awarded. When the grant funds are applied to these purchases, the short fall becomes a surplus of \$6,578

I recommend the Board of Trustees wave bid and award a contract to Haggerty Ford of West Chicago in the amount of \$255,525 for the purchase of the six vehicles listed above. Please submit this item to the Village Board for their consideration at the June 15, 2023 meeting.
