Mr. Ray Urban, 1105 East Washington Blvd., contacted the Village by email with concerns regarding the street width and speeding (see attached email). His vehicle has been sideswiped 3 times over the years. Mr. Urban also reported that Pace bus drivers have had to knock on resident's doors to have them move their vehicle so the bus can get through. Washington Blvd. is 26' wide in this area. Pace uses Washington Blvd. as part of its route through Lombard. Pace buses are normally 8 feet wide and 40 feet long. When two vehicles are parked across from each other, there is only 2.5 feet on either side of the bus to negotiate, providing the vehicles park against the curb.

Letters were sent to residents along Washington Blvd. asking for their input on the "No Parking" restriction. Only one negative response was received (see attached).

Based on the above information, staff would recommend posting the north side of Washington Blvd. "No Parking" between Westmore/Meyers Rd. and Addison St.

As we all are trying to make our houses look nicer, and all of my neighbors have done something to their home now we still have to watch out for our selfs and our personal property. One thing i dont understand is the routing of the pace bus sysyem, why does it run through our village on madison then it cuts over to washington for 2 blocks in our town, why not keep them on the same straight street they came off of. Madison is wider than washington then when they enter villa park they have a curve that the buses have to go thru, years ago they put the police radar trap on our street, the ones that really enjoyed it was the motorists to see how fast they could get their car up to.

So as i sit here trying to figure out where i am going to get my \$1000.00 deductables from,i am looking for your help to try to reduce the speeding of the cars and the very rude bus drivers that travel our streets

Last year we put a very large addition on to my home, we decided to stay put here in lombard as my wife and children are very happy here, as the construction was going on we had many occurances with the pace drivers because their buses didnt fit down the street. they would come knocking on the door complaining that their route was being messed up due to our trucks, but its amazing that when the fire hydrant got hit on washington and westmore one day they closed our street to repair it that the buses still made their route a different path.
