Subject: FY24 Vehicle Replacement, Ford Escape and Ford Police Interceptor Utility

The FY 2024 budget includes replacement of a Ford Escape from the Public Works Engineering fleet as well as an Interceptor Utility from the Police Patrol Fleet. The Interceptor Utility will be the fifth and final Police Patrol vehicle purchased for FY2024. The Village was limited to 4 units previously ordered earlier in the year as 2024 model year vehicles. Ford has opened the order window for the 2025 model year vehicle allowing us to place an order for the 5th unit. Ford will begin production of the 2025 model year vehicle in mid-2024. A second unit of the Interceptor Utility will be purchased for the Fire Department Admin Fleet. This vehicle will add to the fleet and serve as a vehicle for the new second Fire Deputy Chief. The Ford Escape is a scheduled replacement of a like vehicle from the Engineering Fleet.

Both the Escape and Interceptor Utility are available for joint purchase through the Suburban Purchasing Cooperative (SPC contract #204 and #206). The current contract winner is Currie Motors of Frankfort (IL). The cost of the Escape is \$29,461 and the Utility Interceptors are \$48,738 each.

Staff recommends the Board of Trustees waive bid and award a contract to Currie Motors of Frankfort (IL) in the amount of \$126,937 for one new Ford Escape and two new Utility Interceptors. Please submit this item to the Village Board for their consideration at the March 21, 2024 meeting.
