S. Lombard Sanitary Sewer Extension Design Engineering Contract

South Lombard Sanitary Sewer Extension is a project included within the approved 2022-2031 Capital Improvement Program. The 2023 construction project budget is \$450,000 (Water/Sewer Capital Village funds), with Village budgeted funds of \$50,000 for 2022 design engineering/geotechnical services and \$40,000 for 2023 construction observation/material testing services. The project is scheduled for design in 2022 and construction in 2023. The Village will create separate professional services contracts awarded in actual fiscal years.

This sanitary sewer improvement project will add a sanitary sewer extension to improve downstream sewer capacity relief by 22nd Street near the Glenbard Wastewater Authority. The project is located on Village and ComEd property. The project includes ComEd easement acquisition, sanitary sewer installation, and junction chamber improvements.

A Request for Proposal (RFP) was sent to all eligible firms on both 2021 Design and Resident Engineering Shortlists. Baxter & Woodman was determined by the Public Works selection evaluation team to be the most qualified firm. The contract scope and fee for design engineering and construction observation were negotiated and agreed to by both parties. Since this work will occur in separate fiscal years, this 2022 contract work will be performed for a total design engineering fee not to exceed \$49,980.00 from the Water and Sewer Capital Engineering Fund.

Please present the attached agreement and resolution for the contract to the President and Board of Trustees for their review at their regular meeting of December 16, 2021. If approved, please return two original signed copies of the agreement to Public Works for further processing.
