Subject: Sanitary and Storm Sewer Closed Circuit Television (CCTV)

Inspection and Cleaning Program (FY 24)

The Sewer Cleaning and Televising Program is a principal tool that assists staff in managing the Village's sewer systems. Through the cleaning and televising process and utilizing the Village's Geographic Information System (GIS) in conjunction with the Asset Management Software (Cartegraph), staff can catalog and access the sewer system network's current operational and structural condition. This aids in effectively programming future capital project planning, routine maintenance, and scheduling necessary repairs.

#### **Budget:**

The FY 24 Capital Improvement Plan (CIP) budget for RM PROG 50 (Sewer Collection System Maintenance) is \$136,000.00.

#### **Bid Results:**

Bids were published on January 25, 2024, both in the Lombardian and online through QuestCDN. A total of 7 potential bidders downloaded the project documents. On February 27, 2024, at 11:00 A.M., 7 electronically received bids were publicly opened and read in the Public Works Building Front Conference Room. One bid was rejected as the bidder failed to insert a unit price for 17 of the 18 bid items. Results are tabulated below.

Under the General Terms and Conditions of the contract, the Village retains the option (with contractor concurrence) to renew the contract for an additional year. The contract document includes that allows unit prices to be increased per the Consumer Price Index, of the Chicago-Naperville-Elgin area. Renewable multiple-year contracts are a current Public Works practice for various infrastructure maintenance-related contracts.

#### **Recommendation:**

Public Works recommends awarding the contract to Sewertech, LLC of Schaumburg, Illinois for \$86,541.50 Please present this item to the President and Board of Trustees for their review and approval at their regular March 7, 2024, meeting. Please return a copy of the counter-signed contract to Public Works Engineering for further processing.

## CONTRACT DOCUMENT NUMBER RM PROG 50 (FY 24)

This agreement is made this 7th day of MARCH 2024, between and shall be binding upon the Village of Lombard, an Illinois municipal corporation (hereinafter referred to as the "Village"), and Sewertech LLC (hereinafter referred to as the "Contractor") and their respective successors.

Witnessed, that in consideration of the mutual promises of the parties delineated in the Contract Documents, the Contractor agrees to perform the services and the Village agrees to pay for the following services as outlined in the Contract Documents:

Contract quantities and the associated unit prices within the bid proposal for CCTV Inspection - Sanitary (6" - 12", 15" & 21"), Storm (10"-12", 21" & 27") Heavy Cleaning - Sanitary (6" - 12", 15" & 21"), Heavy Cleaning Storm (10"-12", 21" & 27") Sewer Condition Evaluation (6" - 12", 15", 21" - 27") and Maintenance of Traffic for a total of \$86,541.50,

- 3. All televising, cleaning, and agreement to final contract quantities must be completed by October 31st of each year (Substantial Completion Date). All videos and deliverables must be submitted by no later than November 15th of each year (Final Completion Date). Sewers marked as a priority (per Appendix A) must have videos and all associated required submittals delivered by August 1st (Assignment Completion Date) of each year. Time is of the essence regarding this Contract, and the Contractor agrees to achieve completion within the time permitted by all proper and appropriate means including working overtime without additional compensation.

- 4. According to the provisions of Section 5 of the Mechanics' Lien Act of Illinois, before making any payment to the Contractor under this Contract, the Village demands that the Contractor furnish a written statement of the names of all parties furnishing labor and/or materials under this Contract and the amounts due or to become due to each. This statement must be made under oath or be verified by affidavit. The Village shall not issue final payment nor shall any retained percentage become due until releases and waivers of lien have been supplied as the Village designates.
- 5. This Contract represents the entire agreement between the parties and may not be modified without the written approval of both parties.
