Pomp's Tire Service Inc., for Village vehicles in an amount not-to-exceed

Fleet Services purchases tires and tire services from Pomp's Tire Service Inc. and is satisfied with their pricing, service and product availability.

Pomp's Tire Service Inc. has provided Fleet Services with prompt and expert service. They have constantly been able to source any tire needed for Village vehicles with short lead times. Pomp's Tire Service Inc. provides tires through manufacture government contract pricing. These contract prices encompass the majority of the tires purchased throughout the year.

Pomp's Tire Service Inc. also dismounts and mounts new heavy truck tires on large Village vehicles and Fire Department apparatus. To provide this service at a reduced cost to the Village, Pomp's will pick up the wheels removed by Fleet Services, bring them back to their shop to have them dismounted and mounted and then return the wheels to Fleet Services. This saves the Village service charges and increased hourly rate of the road a service truck to perform this work onsite.

Staff recommends the Village Board approve the purchase of tires and tire services form Pomp's Tire Service Inc. in an amount not-to-exceed \$40,000. These funds are provided for in the FY 2025 budget.
