Bachner: light poles in downtown area that are still missing - are these going to be replaced? Dratnol: yes, they are being sandblasted and will be reinstalled.

Arnold: signage in areas that there was no construction and not in areas that were under construction.

Kuehl: were we not supposed to be working on Maple this year? Dratnol: we are still looking at Maple - funding issues. Mahal: diamond cutting seems to work great - couldn't we do more of this type of work? Dratnol: this needs to be addressed in the CIP.

Kuderna: open holes in the area of Central and the High School? Dratnol: those should all be taken care of by now.
