RESOLUTION REGARDING THE DESIGNATION OF CERTAIN BANKS, INVESTMENT BROKERS, AND MUNICIPAL INVESTMENT POOLS AS APPROPRIATE DEPOSITORIES OF VILLAGE FUNDS AND AGENTS FOR VILLAGE INVESTMENTS
