RE: Budgetary Item for FY2026-Agreement with Axon Enterprise-LEGISTAR #250210

Background

On October 15th, 2020, the Village Board passed a resolution (Legistar #200336) entering into an agreement (attached) with Axon Enterprise to provide Taser 7 equipment, training, and services for a five-year period. The amount of this agreement was \$224,572.30 broken up into five (5) annual payments of \$44,914.46.

On December 3rd, 2020, the Village Board passed a resolution (Legistar #200367) entering into an agreement (attached) with Axon Enterprise to provide body worn cameras, patrol car cameras, training, services, and related equipment for a five year period. The amount of this agreement was \$423,283.98 broken up into five (5) annual payments of \$84,656.79.

The total cost for both agreements for the five-year term was \$647,856.28 (\$129,571.26 annually).

The equipment and services obtained by both of these agreements has been essential to the day to day operations of the police department over the past five years. We have been very satisfied with the quality of the equipment, training, and services rendered by Axon Enterprise.



Review of Current Agreement with Axon

Based on our positive experiences with Axon Enterprise, Deputy Chief Ranallo and I began speaking with our sales representative in late January of this year.

While reviewing our account, we discovered the following:

- We had exceeded the number of "pro" licenses (24 more) included in our current agreement.
- We had exceeded our 3rd party digital storage (storage of digital evidence not captured by body camera or squad car camera) by more than double what was included in the agreement. Secure storage of this type of evidence is both legally required and crucial to the prosecution of criminal cases, as it includes surveillance camera footage, cellphone evidence, and more.
- We had access to "Respond", which allows our supervisors to see the location of
 officers' body cameras and the patrol car cameras on a situation map. It also
 allows authorized personnel to watch the body cameras or patrol cameras
 remotely during critical incidents or incidents where there is a threat to officer
 safety.

Despite the above, our sales representative said we were not being billed for any of the three items and were thus receiving them without additional cost. The value of these items was \$217,392.00 for the five-year term (\$43,378.40 annually).

As a result, while our annual expense for the last 5 years was \$129,571.26, the actual value of the services we received was \$172,949.66. This amounts to a discount of 25% over the actual cost that saved the Village \$216,890 in terms of the value based upon the services provided. The total value of services provided for the last 5 years amounted to \$864,745.

Deputy Chief Ranallo and I evaluated all three of these items and determined the following:

- We needed a larger number of "pro" licenses, as these types of licenses are required to perform certain important functions in the Axon system. This includes functions such as field training officers' ability to view trainee videos, sharing evidence with the State's Attorney's Office, and more.
- We needed more 3rd party digital storage (storage of digital evidence not captured by body camera or squad car camera) due to the increase in the amount of this type of evidence that we are receiving as part of our cases. Storage of this evidence on the cloud-based Axon platform is the most secure option as well as the most cost effective due. This is due to the fact that it requires no IT staff time



- or hardware resources, both of which would carry their own significant costs. As stated above, secure storage of this type of evidence is both legally required and crucial to the successful prosecution of criminal cases.
- The Axon "Respond" feature has been used frequently by supervisors monitoring situations remotely while enroute and in a few circumstances where officers were fighting with subjects and could not talk on the radio. The use of this feature has allowed supervisors to coordinate resources on larger incidents and get officers help when they needed it most.

Based on this, we informed the sales representative that we would like all three of the above in the next agreement.

In addition to the above, we requested that a feature called "Auto-tagging" be added as well. This feature automatically identifies and categorizes body worn camera and patrol car camera videos based on a link with our dispatch center. The reason for our request is that one of our challenges in the past five years has been making sure that all videos are properly identified manually and categorized by officers. Manual identification and categorization of videos by officers has added on to their daily workload. Additionally, if an officer fails to properly identify or categorize their videos it could lead to accidental deletion of the video and/or our failure to properly tender the video as evidence to the State and defense. This creates the possibility of significant civil liability if either occurs. Auto-tagging would reduce this liability by ensuring videos were properly identified and categorized so they are retained and properly tendered during the discovery process.

We also requested that the sales representative provide pricing information on Axon Interview Room, a video recording product that would be installed in our three interview rooms at the police department. This would replace an aging video system that we have experienced significant issues with that include poor sound, no sound, and poor video quality. Videos obtained during interviews and interrogations are extremely important for criminal cases. Though not required, officers have been wearing their body worn cameras or mounting them to the wall in order to ensure that their interviews or interrogations are of sufficient quality to be used in court. The Axon Interview Room product also automatically uploads the video evidence directly to Axon's storage platform.

Pricing

We asked the Axon sales representative for a quote based on the above. He advised us the pricing and costs had increased significantly since our last agreement with Axon. He advised that Axon now sells equipment and services in three different bundles to make things more economical for agencies. He told us that all of our needs were included in one of the bundles. We asked if any services were still available a la carte (example: unlimited storage) that might allow us to save money. He advised us that Axon does still



make that available, but it is typically at a higher cost than the one that would be paid by including that service as a bundle. He used the unlimited storage example to provide us with some pricing. He advised us that it would be more expensive to purchase a cheaper bundle with unlimited storage added than to buy the bundle that included unlimited storage.

Based on our needs, the Axon representative advised us that the best bundle for our agency also included a number of other services that were upgrades. They include but are not limited to:

- An AI Redaction Assistant to reduce the amount of time necessary to redact videos for FOIA.
- Axon Investigate-A forensic video tool for investigators' use of third party video.
- Axon virtual reality training-a VR training tool that allows officers to complete scenario based training in virtual reality.
- Axon Standards-a product to evaluate officer performance related to body worn camera video and patrol car camera video footage.
- An upgrade to TASER 10, the latest taser product that has significant advantages over the current tasers being used by the department. Both equipment, training, and certification are included.

The sales representative also advised us that the Axon Respond feature we were asking for was currently being replaced by a product called FUSUS. This product not only includes the ability to see officer body worn camera and patrol car video live along with locations on a map, but also includes the following:

- The ability to see our Flock license plate readers and alerts on the same map
- The ability to add up to 250 streams of live and recorded video to the same map, including some hardware devices to facilitate those streams if needed.

This feature would allow us to see live video from our officers and license plate readers along with video from participating entities (businesses, schools, etc) as well as live traffic cameras from the Dupage County Highway Department all on one screen with the click of a button. Also included would be any video on the village campus or train station as well as live video from police drones that may be in use.

There would be clear operational advantages to having all of this video available live to officers responding to incidents as well as supervisors who may be monitoring incidents remotely. The FUSUS product is included in the bundle the sales representative recommended.

Quote



The final quote provided by Axon (attached) was for \$1,905,355.79 over five years. This takes advantage of this year's pricing. Axon agreed to structured payments in the following amounts that Finance Director Tim Sexton requested:

September 2025: \$19,054.51 (to bridge and combine current agreements)

January 2026: \$316,288.88 January 2027: \$358,206.70 January 2028: \$381,071.00 January 2029: \$403,935.20 January 2030: \$426.799.50

The final quote includes \$1,057,931.61 in discounts. These discounts include the following zero cost items:

- Upgrade to the latest body cameras and related equipment
- Interview room cameras and service for all three rooms

The final quote also contemplates discounted pricing for upgrades to our patrol car cameras to the Fleet 3 product, a much better system that had integrated license plate readers.

Recommendation

The police department recommends entering into the proposed agreement with Axon as proposed in the quote. This agreement would actually enhance the levels of equipment and services the police department has while also increasing operational effectiveness..

While the cost is significantly higher than that last agreement, this cost is on par with the rest of our industry. As you know, body worn cameras and patrol car cameras have been crucial in not only investigating and responding to crimes, but also in investigating and defending officer's actions. The investigation of Detective Postal's officer involved shooting incident in 2022 was made far easier and the conclusion far clearer because of the quality of equipment and services that we have with Axon. It is important to noted that as of 2025, there is an unfunded mandate under state law for all law enforcement officers to be equipped with body worn cameras.

The cost of this entire five-year agreement is far less than many agencies have paid in lawsuits related to use of force incidents or pursuits where there was no video or poorquality video to tell the story of what occurred.

The aforementioned prices are projected to coincide with the start of our fiscal year on January 1, 2026. As such, we respectfully requested if Axon could hold their pricing until October of 2025 which would allow us to present this significant financial commitment as part of the annual budget process. However, due to their current workload and back log of other interested agencies, they advised that the pricing provided would only be



offered through June 30, 2025. As such, we are respectfully requesting Village Board consideration of this contract at the June 19, 2025 meeting. This is similar to the approach we have seen in terms of purchasing large equipment such as fire engines, ambulances and squad cars where advance contractual commitment is needed ahead of final budget approval in order to secure our spot in the delivery queue.

Sufficient funds have been included in our FY 2026 budget request. In addition, this item has been thoroughly vetted by the Finance Department and IT Staff in terms of technology integration and capacity of our systems.
