WHEREAS, on June 15, 2006 the VILLAGE and CONSULTANT executed a contract regarding certain engineering services relative to the South Booster Station, Design Engineering; and

WHEREAS, the VILLAGE and CONSULTANT have agreed to increase the amount of work to be performed by the CONSULTANT together with a resultant increase in the limit which the contract sum may not exceed;

NOW, THEREFORE, for and in consideration of the foregoing and various covenants in said agreement and the mutual covenants herein contained, it is agreed by and between the parties as follows:

SECTION 1: The aforementioned contract shall be amended to expand the scope of work as provided for in the CONSULTANT'S November 29, 2006 letter.

SECTION 2: The aforementioned contract shall be amended to show a contract sum not to exceed \$261,952.69.

SECTION 3: All other terms, covenants and conditions of said contract heretofore executed which are not amended or deleted herein shall remain in full force and effect.

Christopher B. Burke Engineering, Ltd (CBBEL), of Rosemont, was awarded the design engineering contract in an amount not-to-exceed \$169,105.60, for the design and preparation of construction documents for the project (Phase I and Phase II engineering). Design Amendment #1, approved on January 4, 2007, was for the preparation of Plat of Survey and Plats of Easements in the amount of \$22,943.21 and increased the contract not-to-exceed amount to \$192,048.81.

Public Works and Christopher B. Burke Engineering, Ltd (CBBEL) reviewed the South Booster Station's design contract based on the recent decision on the route of the water transmission main. The requirements for designing the new water transmission main route include surveying (which was completed for the earlier route) and additional design effort that was expended on the earlier route. Additionally the amendment covers technical support the Firm provided on assessing alternative alignments for the water transmission main.

The Engineering Division recommends an amendment to this contract in the amount of \$69,903.88, which will bring the total contract not-to-exceed amount to \$261,952.69. The Village Water/Sewer Capital Reserve Fund will fund this project.

Please present this amendment to the agreement and resolution to the President and Board of Trustees for their review and approval at their regular meeting on August 9, 2007. If approved, please have both signed copies returned to Engineering for further processing.
