In the absence of Trustee Zach Wilson, Chairperson of the Transportation and Safety Committee, Chief Byrne indicated staff liaison Deputy Chief Pat Rollins had advised that the committee reviewed several items at their last meeting.

Board of Local Improvements - Trustee Greg Gron, President

Trustee Greg Gron, President of the Board of Local Improvements, reported the board had not met. The next meeting is scheduled for November 10th.

Community Promotion & Tourism - President William J. Mueller, Chairperson Play Video

President William Mueller, Chairperson of the Community Promotion and Tourism Committee, reported the committee had not met.

Lombard Historical Commission - Clerk Brigitte O'Brien

Play Video

Clerk Brigitte O'Brien, member of the Historical Commission, reported the commission had met. The commission discussed proposed modifications to the existing Use Agreement between the Village and the Lombard Historical Society, much of which was related to the proposed addition to the Coach House. Some changes were suggested.

A presentation was given of the Coach House plans, which would effectively double the size of the carriage house with a two-story addition to the south. At this point a grant of \$70,000 will be given by the State in order to make the building ADA accessible. Future fundraisers for the remainder of the cost will include a Silent Auction at Harry Caray's on November 20th. Dan Tani will be the guest speaker, and people from Lombard's historical past will be in attendance.

Plaques designating Lombard landmark sites have been installed at the Dairy Queen and the home at 125 E. Washington. The Commission requested that an article about the Local Landmark plaques be placed in the December/January issue of the Pride. The Local Landmarks Committee will move forward with an application for Local Landmark designation of the Lombard Cemetery, which is expected to proceed in January 2012. A cleanup of the Cemetery was held on September 9th. A thank you goes to the volunteers from Oxford Bank, who gave of their time and effort. Some of the stones in the cemetery have been displaced, and work will be done to reposition them. The Sheldon Peck Homestead was listed as part of the National Park Service's Underground Railroad Network to Freedom program. It is currently the only recognized site in the Chicagoland area.

The National Register of Historic Places application for the Sheldon Peck Homestead will be re-introduced at the March 2012 Illinois Historic Sites Advisory Council meeting. It will include additional information requested by the council members on September 9. The Commission discussed the creation of an annual historic preservation award to be presented by the Commission in recognition of individuals, organizations, projects, and programs demonstrating a commitment to excellence in historic preservation. The proposed schedule is to solicit nominations in the spring, judge the applications in July, and present the awards in October (to coincide with National Preservation Month). A commercial plug: The Historical Society will be hosting a Civil War Encampment at the Lombard Commons this weekend, October 22 & 23. There will be a pig roast on Saturday. This was a good opportunity for residents to interact with police, fire and public works staff. President Mueller talked about the intergovernmental cooperation with attendance at the Touch a Truck event by the York Center Fire Department, DuPage County Sheriff's Office and other agencies.
