The Community Promotions & Tourism Committee met on March 12, 2013 and reviewed a hotel/motel tax grant application from the Lombard Historical Society. The grant request is to help fund a Civil War Encampment in Lombard in July. The grant application and budget are attached for your information.

The grant request is for \$6,000 and would be used for entertainment costs associated with the event including music, reenactment supplies, advertisements and logistical costs.

#### **HISTORY**

In 2012, a \$4,200 grant was requested. The Community Promotions & Tourism Committee reviewed the request and recommended approval to the Board of Trustees who ultimately approved the grant in the full amount for costs associated with the Civil War Encampment.

#### RECOMMENDATION
