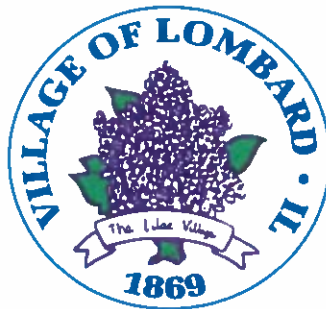

ORDINANCE NO. 7288

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class “C” liquor licenses, contained therein, to read as follows:

Class “C” - 8

This decrease in the number of Class “C” liquor licenses reflects a change in ownership of Patio Restaurant of Lombard, Inc. d/b/a Patio Restaurant located at 2780 S. Highland Avenue, and the termination of the Class “C” liquor license issued to Patio Restaurant of Lombard, Inc. in relation thereto.

Section 2: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class “C” liquor licenses, contained therein, to read as follows:

Class “C” - 9

This increase in the number of Class “C” liquor licenses reflects the issuance of a new Class “C” liquor license to Patio Restaurant of Lombard, Inc. d/b/a Patio Restaurant located at 2780 S. Highland Avenue, Lombard, IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.


