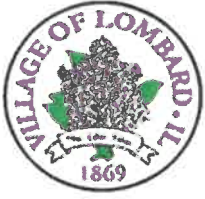

SUBJECT: Request for an Increase in the Number of Class “B” Coin-Operated Licenses
Dave & Buster’s

The Village Code, Title XI, Chapter 110, Section 110.21(C) has two categories for the Coin-Operated Amusement Devices, Classes A and B, with the following number of allowances:

Class A – Four to Eight Coin-Operated Amusement Devices

Class B – More than Eight Coin-Operated Amusement Devices

The newly added business to the Village of Lombard, Dave & Buster’s, will make their arrival this coming fall 2024. Dave & Buster’s is a well-known entertainment establishment with a full dining experience and an environment that includes amusement in the form of coin-operated amusement devices. The owners are requesting the allowance of 97 coin-operated amusement devices on the premises, which requires a Class B Coin-Operated Amusement Device license.

Currently there are three (3) Class B licenses, (Enchanted Castle, The Game Room, and At the Pier).

Attached is an Ordinance reflecting the increase of licenses allowed, from three (3) to four (4) to bring the number of Class B licenses current.

Please place this item on the August 15, 2024, Village Board of Trustees agenda for consideration.

Petitioner is requesting a waiver of first reading to reflect these changes and to have the coin-operated devices active upon opening.

ORDINANCE NO. _____

AN ORDINANCE AMENDING TITLE XI, CHAPTER 110,
SECTION 110.21(C) OF THE LOMBARD VILLAGE CODE
IN REGARD TO THE NUMBER OF
CLASS A COIN-OPERATED LICENSES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

SECTION 1: That Title XI, Chapter 110, Section 110.21(C) of the Lombard Village Code is hereby amended to read as follows:

(C) In addition to the license required by subsection (B) for each individual coin-operated amusement device, there shall be issued no more than the stated number of annual licenses in the following classifications for persons, firms, corporations or associations displaying for public patronage or keeping for operation any coin-operated amusement device:

Class B

More than eight coin-operated amusement devices.

No more than ~~three~~ four licenses.

SECTION 2: That this ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.
