The following is a recommendation from staff to approve the funding for a one-year renewal agreement with Granicus for a period from 04/01/2023 to 03/31/2023 in the amount of \$36,100.45.

## BACKGROUND

Granicus has been providing services to support Legistar meeting documents and media functions to host Board of Trustee and Plan Commission broadcast meetings; as well as other non-meeting programs, since February 10, 2009.

Attached is the proposed Granicus agreement that will provide the Village of Lombard with the Granicus Software to continue the automation and management of the Legistar agenda process, which includes drafting files, minutes and final committee and Board actions. Legistar and Granicus also provided the continued ability to post agendas/documents and provide software and hardware (Meeting Efficiency Suite) to manage in-meeting and post-meeting video capture and broadcasts.

### RECOMMENDATION

Staff recommends renewing with Granicus for a one-year period and continue a smooth flow of the necessary services without interruption. There is an increase in the proposed contract of approximately 7% increase from the current contract of \$33,738.74.
