Subject:

Pedestrian Crossings, Stop Signs and Speeding on Maple St. between Grace St. and

Westmore/Meyers Rd.

The Village received an e-mail from Ms. Regimand at 412 E. Maple St. Ms. Regimand requested that the Village look into installing pedestrian crossings and stop signs at Fairfield Ave. and Ahrens Ct. at Maple St. She also requested that the speed limit on Maple St. be reduced from 30 MPH to 25 MPH.


After reviewing this request, I agree there should be pedestrian crossing signs installed with pavement markings on the west leg of Maple St. and Fairfield Ave., and on the east leg of Ahrens Ct. and Maple St. at Ahrens Ct. Sidewalk extensions will need to be installed from the public sidewalk to the street on the north and south sides of Maple St. to accommodate pedestrians. These signs and markings will help make these crossings more visible to drivers.

With the recent lowering of the speed limit to 25 MPH on Madison St. and Washington Blvd. due to parks and schools in the area, I find Maple St. functioning in a similar manner. I reviewed Maple St. not just in this area, but the entire street segment (Finley Rd. to east Village limits), for possible speed reduction. My findings show two schools, six churches, the Helen Plum Library, Lombard Historical Museum, two recreational parks, two commuter parking lots and Dairy Queen. Dairy Queen was included due to the large draw of pedestrians to this area.

Fairfield Ave. is located approximately 630 feet east of Grace St. which is a multi-way stop intersection. Ahrens Ct. is located approximately 520 feet west of Westmore/Meyers Rd. which is a signalized intersection with pedestrian phasing. I feel Fairfield Ave. and Ahrens Ct. are located within a reasonable walking distance to a fully controlled intersection. The pedestrian signage with markings, along with a speed reduction on Maple St., will make crossing Maple St. at Fairfield Ave. and Ahrens Ct. much safer.

On the basis of the above information, I would recommend installing pedestrian crossings and markings on Maple St. at Fairfield Ave and Ahrens Ct. I also recommend reducing the speed limit to 25 MPH on Maple St. from Finley Rd. to east Village limits. I would not recommend converting Fairfield Ave. and Ahrens Ct. at Maple St. to a multi-way stop.
