Waive bid, purchase backhoe using federal contract

Included in the FYE 05/06 budget is a replacement for village unit # SM473, a 1997 John Deere Backhoe for the public works sewer division. The federal government contract #GS-30F-1021D allows a 40.6% discount for the Village. Based on previous bids for backhoes, the Village could not obtain such a discount through an open bidding process.

The federal government bid price for the John Deere backhoe is \$77,169 less a trade-in allowance of \$26,000 equals a net total bid of \$51,169. The budgeted amount is \$80,000.

I recommend waiver of bid and the award of a contract to Westside Tractor Sales of Naperville, IL. in an amount not to exceed \$51,169. I also recommend declaring village unit # SM473 as surplus per the attached ordinance and authorizing its trade-in. Waiver of first reading is requested on this ordinance. Please submit this item to the Village Board for their consideration at the August 18, 2005 meeting.
