Plow and liftgate upfit for Ford F-250 trucks

The FY 2024 budget included purchase of four Ford F-250 4X4 pick-up trucks with snowplows and liftgates. These vehicles were not able to be purchased with the snowplows and liftgates upfit from the selling dealer. The trucks have been received and now need to be upfit with the snowplows and lift gates. Quotes have been requested from three local equipment upfitters to provide and install Western snowplows and Tommy Gate liftgates on the four trucks. The cost of this equipment was factored into the vehicle replacement cost included in the FY 2024 budget form the vehicle reserve fund. After reviewing the quotes received, Regional Truck Equipment of Addison (II) proposed the lowest price.

Staff recommends the Board of Trustees waive bid and award a contract to Reginal Truck Equipment of Addison (IL) in the amount of \$40,273 to upfit 4 Ford F-250 pickup trucks with snowplows and liftgates. Please submit this item to the Village Board for their consideration at the September 19, 2024 meeting.
