**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112,
SECTIONS 112.12(A), 112.13(A), 112.14(A) AND
112.40(A) OF THE LOMBARD VILLAGE CODE IN
REGARD TO LIQUOR LICENSE CLASS “VVV”**

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, IL as follows:

Section 1: That Title XI, Chapter 112, Sections 112.12(A), 112.13(A), 112.14(A) and 112.40(A) of the Lombard Village Code are hereby amended by deleting the Liquor License Class “VVV”, and all references thereto, in their entirety.

Section 2: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
