Request for a Class "EE" Liquor License

WickedBall Incorporated – 106 Yorktown Shopping Center – New Location

The owner of WickedBall Incorporated d/b/a WickedBall Chicago, located at 332 Yorktown Shopping Center, currently holds a Class "EE" liquor license. The primary purpose of this establishment is the sale of beer and wine only, served as an adjunct to a place of amusement, for consumption on the premises only and only by paying patrons of the place of amusement. Full description below:

Class "EE"—Beer and wine only served as an adjunct to a place of amusement not covered by a Class "E", Class "M" or Class "R" liquor license, for consumption on the premises only and only by paying patrons of the place of amusement (those individuals who have paid for access to the amusements on the licensed premises). Kitchens shall be allowed; further, food may be provided to the patrons, from restaurants that have entered into an agreement with the liquor licensee to deliver carry-out food to the licensed premises. However, licensees shall be required to provide or sell, at a minimum, pre-packaged snacks, such as pretzels and potato chips in the manufacturer's original packaging, to patrons of the licensed premises. No package sales shall be allowed. Video gaming, as provided for under the Illinois Video Gaming Act, shall not be allowed on the licensed premises.

The Village has received a request for a Class "EE" liquor license from the current owner of WickedBall Incorporated d/b/a WickedBall Chicago, for the new location, 106 Yorktown Shopping Center, for the July 1, - December 31, 2025, license term.

WickedBall Chicago opened in Lombard in 2018. WickedBall is an interactive, family-friendly entertainment venue offering a range of immersive physical activities, games, and team-building experiences.

Attached is an ordinance amending Title XI, Chapter 112, Section 112.13(A) decreasing and increasing the Class "EE" liquor license category by one (1) relative to the Entity Liquor Licensee WickedBall Incorporated no longer conducting business at 332 Yorktown Shopping Center and

issuance of a Class "EE" Liquor License to conduct business at the new location, 106 Yorktown Shopping Center.

Staff is requesting a waiver of first reading at the July 17, 2025 Board of Trustees meeting.

ORDINANCE	

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13 (A) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "EE" liquor license category, contained therein, to read as follows:

Class "EE" - 1

This decrease in the number of Class "EE" liquor licenses reflects the ceasing of business by WickedBall Incorporated d/b/a WickedBall Chicago, at 332 Yorktown Shopping Center and the termination of the Class "EE" liquor license issued to WickedBall Incorporated in relation thereto.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "EE" liquor license category, contained therein, to read as follows:

Class "EE" - 2

This increase in the number of Class "EE" liquor licenses reflects the issuance of a Class "EE" liquor license to WickedBall Incorporated d/b/a WickedBall Chicago who will be operating the business, at its new location, 106 Yorktown Shopping Center, Lombard, IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
