## **ORDINANCE NO. 8351**

## AN ORDINANCE AMENDING VARIOUS SECTIONS OF TITLE XI, CHAPTER 112 OF THE LOMBARD VILLAGE CODE IN REGARD TO CLASS "GGGG" LIQUOR LICENESES

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That Title XI, Chapter 112, Article II, Section 112.12(A) of the Lombard Village Code, is hereby amended by adding a new Class "GGGG" liquor license, to read in pertinent part as follows:

"Class "GGGG" – Package sales allowed as an adjunct to a food cooperative where the interior floor area designated for the sale of groceries is no less than 5,600 square feet. The primary purpose of a Class "GGGG" licensee shall be the sale of food and foodstuffs. The area set aside for liquor sales and storage shall not exceed 200 square feet. For the purpose of this section, a food cooperative is defined as a member-owned retail establishment operating on a cooperative model. Unlike traditional grocery stores owned by individuals or corporations, food cooperatives are democratically controlled by their members, who share in profits and decision-making. These stores prioritize local, sustainable, and organic products, emphasizing community well-being and engagement over profit maximization. Video gaming, as provided for under the Illinois Video Gaming Act, shall not be allowed on the licensed premises."

**SECTION 2:** That Title XI, Chapter 112, Article II, Section 112.13(A) of the Lombard Village Code, is hereby amended by adding a row to the table for Class "GGGG" liquor licenses and reflecting that the number of authorized Class "GGGG" liquor licenses shall be limited to one (1). The new row shall be inserted after the row for the Class "GGG" liquor license. The creation of one Class "GGGG" liquor license reflects the issuance of a Class "GGGG" liquor license to Prairie Food Co-Op, located within the Eastgate Shopping Center, 837 S. Westmore-Meyers Road, Lombard, Illinois.

**SECTION 3:** That Title XI, Chapter 112, Article II, Section 112.14(A) of the Lombard Village Code, is hereby amended by adding a row to the table for Class "GGGG"

liquor licenses and reflecting that the license fee for each Class "GGGG" license issued shall require a semi-annual payment of \$750. The new row shall be inserted after the row for the Class "GGG" liquor license.

SECTION 4: That Title XI, Chapter 112, Article III, Section 112.40 of the Lombard Village Code, is hereby amended by adding a reference to the Class "GGGG" liquor license classification to the list of liquor license classifications referenced in subsection (A), in its proper alphabetic location, as those classifications that are required to have all employees successfully complete the BASSET Program for alcoholic liquor servers.

**SECTION 5**: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
