Billiard/Pool Hall Licenses - Decrease

Whirly Ball, previously located at 800 E. Roosevelt Road, held a Billiard/Pool Hall license. The Village received notification on May 22, 2019, from the owner, that Whirly West Inc. d/b/a Whirly Ball, ceased business operations at 800 E. Roosevelt Road. Attached is an ordinance decreasing the number of authorized billiard/pool hall licenses by one (1).

## Background

Whirly Ball held both a Class "A/B-II" liquor license and a Billiard/Pool Hall license. Ordinance #7674 passed on consent agenda at the Board of Trustees meeting, June 20, 2019, decreasing the number of Class A/B-II liquor licenses by one as a result of Whirly Ball, located at 800 E. Roosevelt Road, no longer conducting business at that location. Accordingly, the billiard/pool hall license is also affected, and as a result of the licensee, Whirly West, Inc. no longer conducting business at that location, staff is requesting a decrease in the number of authorized billiard/pool hall licenses by one (1).

Staff is requesting a waiver of first reading to bring the number of authorized Billiard/Pool Hall licenses current, under Section 110.08 (E).

### **ORDINANCE**

# AN ORDINANCE AMENDING TITLE XI, CHAPTER 110, SECTION 110.08(E) OF THE LOMBARD VILLAGE CODE TO REDUCE THE NUMBER OF AUTHORIZED BILLIARD/POOL HALL LICENSES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

**SECTION 1:** That Title XI, Chapter 110, Section 110.08(E) of the Lombard Village Code is amended, to read in its entirety as follows:

(E) The number of billiard/pool hall licenses authorized in the Village is zero (0). No new billiard/pool hall licenses shall be issued.

SECTION 2: That the change in the number of billiard/pool hall licenses set forth in Section 1 above, is a result of Whirly West, Inc. d/b/a Whirly Ball, no longer conducting business at 800 E. Roosevelt Road, Lombard.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
