## ORDINANCE NO. 5214

## AN ORDINANCE GRANTING AN EXTENSION OF ORDINANCE 5070

(PC 01-23: 203, 233 Eastgate Road, 1807 S. Highland Av, 567 S. Stewart Av., Lombard, IL)

WHEREAS, on January 17, 2002, the President and Board of Trustees of the Village of Lombard adopted Ordinance 5070 that granted a conditional use for a planned development to allow for the construction of a medical office building at the southeast corner of Highland Avenue and Eastgate Road, in Lombard, Illinois; and,

WHEREAS, pursuant to Section 155.103 (F)(11)(a) of the Lombard Zoning Ordinance, otherwise known as Title 15, Chapter 155 of the Code of Lombard, Illinois, conditional uses are null and void if construction is not substantially underway within one year from the date of granting thereof, unless further action is taken by the Village Board; and,

WHEREAS, construction has not commenced and no building permit has been issued for the amendment granted by Ordinance 5070; and,

WHEREAS, the Village has received a letter requesting an extension of Ordinance 5070; and,

WHEREAS, the President and Board of Trustees have determined that it is in the best interests of the Village of Lombard to grant said extension.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

SECTION 1: That Condition 6 in Ordinance 5070 is hereby amended and extended as follows:

6. Ordinance 5070 shall be null and void unless a building permit is obtained within twelve (12) months of the date of adoption of this Ordinance, and all construction completed per approved plans within eighteen (18) months from the date of adoption of this Ordinance.

SECTION 2: That all other provisions associated with Ordinance 5070 shall remain in full force and effect.

SECTION 3: This ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.
