Request for a Class "VV" Liquor License

The Makery Bar at Soapy Roads, LLC d/b/a Soapy Roads of Lombard

10 W. St. Charles Road

The Village initially received a request for a Class "VV" liquor license from the owner of Soapy Roads of Lombard, LLC d/b/a Soapy Roads of Lombard, located at 10 W. St. Charles Road for the July 1 – December 31, 2025, license term.

Ordinances 8380 and 8381, respectively, were passed on consent agenda at the August 21, 2025, Board of Trustees meeting amending the Class "VV" and granting issuance of a Class "VV" license to Soapy Roads of Lombard, LLC d/b/a Soapy Roads of Lombard, located at 10 W. St. Charles Road. The applicant has since created a new legal entity, The Makery Bar at Soapy Roads, LLC to appropriately provide evidence of liquor liability for the business and are now required to terminate the newly created license and reapply under the new legal entity.

After review with staff and the Village Attorney, the license approved for issuance to the Soapy Roads of Lombard, LLC will terminate and a new license is created with the new entity, The Makery Bar at Soapy Roads, LLC decreasing and increasing the Class "VV" license category issuing to the newly created legal entity.

Soapy Roads of Lombard, established in 2017, is a family-owned business that made its presence in Lombard and opened its doors, February 14, 2024. Soapy Roads is a small batch artisan gift and experience shop, looking to expand within the same location to offer more onsite experiences beyond soapmaking through various events on a larger scale, to include beer, wine, and champagne only for patrons of the licensed premise attending an event. Food will not be prepared and sold onsite, but the owner will offer and sell prepacked snacks and may bring in food to the patrons via local eateries as well as offering the option for patrons to bring in food and non-alcoholic beverages.

Staff is requesting a waiver of first reading, September 4, 2025, to reflect the current number of licenses in the "VV" liquor license category.

ORDINANCE NO.

AN ORDINANCE AMENDING TITLE XI, CHAPTER 112, SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN REGARD TO THE NUMBER OF CLASS "VV" LIQUOR LICENSES

WHEREAS, the Village of Lombard, DuPage County, Illinois (the "Village"), is a non-home rule municipality duly organized and existing under the Constitution and laws of the State of Illinois; and

WHEREAS, pursuant to the Liquor Control Act of 1934 (235 ILCS 5/1-1 et seq.) the Village has the power to determine the number, kind, and classification of licenses for sale at retail of alcohol liquor; and

WHEREAS, on August 21, 2025, the President and Board of Trustees of the Village granted a Class "VV" liquor license to Soapy Roads, LLC d/b/a Soapy Roads of Lombard (the "Applicant"), for the business located at 10 W. St. Charles Road, Lombard, Illinois, and

WHEREAS, the Applicant has since changed its corporate structure, and has requested that the Class "VV" liquor license be re-issued to The Makery Bar at Soapy Roads, LLC d/b/a Soapy Roads of Lombard, to appropriately provide evidence of liquor liability for the Applicant; and

WHEREAS, pursuant to the Applicant's request, the President and Board of Trustees of the Village wish to terminate the Class "VV" liquor license previously issued to Soapy Roads, LLC d/b/a Soapy Roads of Lombard, and simultaneously issue a new Class "VV" liquor license to The Makery Bar at Soapy Roads, LLC d/b/a Soapy Roads of Lombard, and

WHEREAS, the President and Board of Trustees further wish to waive the \$500 application fee set forth in Section 112.11 of the Village Code, based on the August 21, 2025 approval of the Class "VV" liquor license application for the Applicant, and that this re-issuance concerns only a change in the corporate ownership of the Applicant, and not a substantive change that would require the Village to re-investigate the terms of the Applicant application. Therefore, the President and Board of Trustees of the Village hereby grant the Applicant's request relative to a Class "VV" liquor license, as set forth below.

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

Section 1: That Title XI, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "VV" liquor license category, contained therein, to read as follows:

Section 2: That Title XI, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "VV" liquor license category, contained therein, to read as follows:

Class "VV" - 1

SECTION 3: That the \$500.00 application fee pursuant to section 112.11 of the Lombard Village Code, Alcoholic Beverages, is hereby waived.

SECTION 4: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
