**Telephone Communications Contract** 

The current three year telephone services contract the Village of Lombard has with CallOne will end at the end of 2017. IT Staff contacted three different vendors and asked for quotes to supply telephone connection services to the desk phones at the Village of Lombard.

All of the above costs include 3 PRI lines. The PRI lines provide the ability for the Village to place or receive 71 concurrent telephone calls. The cost above does not include the monthly State and Federal taxes and fees. The taxes and fees would be similar for all vendors.

The total monthly cost of the AccessOne proposal with current taxes and fees included is \$803.20 monthly.

AccessOne provided the lowest quote and provides the same features that CallOne does, which includes conference calling. AccessOne also gives us 1k minutes a month free outbound long distance calling on each PRI line. The free long distance would be an additional \$100.00 a month savings. Total savings compared to our current provider are estimated at \$4,200 per year, or \$12,600.

Staff is requesting authorization to award a contract to AccessOne for a three year telephone communication service contract.
