Amending Parking Restrictions on South Park Avenue between McGuire

and St. Charles Road

Request

Staff recommends that the Village amend Schedule X of the Traffic Code to make the parking stalls 1-hour, customer only parking on South Park Avenue between McGuire Drive and St. Charles Road. Staff also recommends that we retain one 30-minute parking stall and update the Traffic Code to reflect the location.

Background

South Park Avenue between Michael McGuire Drive and St. Charles Road currently has 9 parking spaces on both the east and west side of Park Avenue. All parking is designated as customer only, 2-hour parking, except for:

- The west side, 8th parking stall south of St. Charles Road is 5-minute parking and
- The east side, 5th parking stall south of St. Charles Road is 30-minute parking

A depiction of this can be found in Exhibit A-1.

With the forthcoming work on South Park to convert the west side of the roadway into a pedestrian oriented space, the parking spaces will be reduced to 10 total parking stalls, 1 of which is ADA parking, all on the east side of the roadway.

The reduction in parking and limited turnover for 2-hour parking is a concern for businesses on Park Avenue. As such, staff recommends that the Village amend the parking restriction to 1-hour, customer only parking on South Park Avenue between St. Charles Road and McGuire Drive. Staff also recommends keeping one parking stall as 30-minute only parking. A depiction of this can be found in Exhibit A-2.

Analysis

To achieve the previously explained parking restrictions, the following changes to Schedule X of the Village Traffic Code are required:

Subsection M: 5-minute parking. The 8th parking stall south of St. Charles Road on the west side of Park Avenue is the only street on this schedule.

- Remove existing subsection entirely
- Replace with the language:

(M) In accordance with Section 10-13-10 and when signs are erected giving notice thereof, no person other than customers to local businesses shall park a vehicle and no vehicle shall be parked for a period exceeding one (1) hour between the hours of 8:00 a.m. and 6:00 p.m. on any day except Sundays and holidays in any of the following places:

Subsection P: 30-minute parking

• Change from "5th parking stall south of St. Charles Road" to "8th parking stall south of St. Charles Road"

Subsection Q: 2-hour, customer only parking, 8:00am – 6:00pm on any day except Sundays and holidays.


• Remove the east and west side of Park Avenue from Michael McGuire Drive to St. Charles Road.

Exhibit B displays all of the recommended changes to Schedule X of the Village Traffic Code for subsections M, P, and Q.

Recommendation

The staff recommends an ORDINANCE AMENDING SCHEDULE X OF THE LOMBARD TRAFFIC CODE TO:

- a) ALLOW 1-HOUR CUSTOMER PARKING, 8:00AM 6:00PM, EXCEPT SUNDAYS AND HOLIDAYS ON PARK AVENUE,
- b) RETAIN A 30-MINUTE PARKING STALL ON PARK AVENUE FOR THE 8TH STALL SOUTH OF ST. CHARLES ROAD, AND
- c) REMOVE LANGUAGE OF PARKING ON THE WEST SIDE OF SOUTH PARK AVENUE.





ORDINANCE AMENDING ARTICLE XV OF THE LOMBARD TRAFFIC CODE TO ESTABLISH 1-HOUR CUSTOMER PARKING ON SOUTH PARK AVENUE

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Public Safety and Transportation Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Article X of the Lombard Traffic Code (Ordinance 1186) be amended by completely removing and replacing section M as follows:

(M) In accordance with Section 10-13-10 and when signs are erected giving notice thereof, no person other than customers to local businesses shall park a vehicle and no vehicle shall be parked for a period exceeding one (1) hour between the hours of 8:00 a.m. and 6:00 p.m. on any day except Sundays and holidays in any of the following places:

Section 2: That Article X of the Lombard Traffic Code (Ordinance 1186) be amended by changing the language in section P as follows:

"Park Avenue, east side, 5th 8th parking stall south of St. Charles Road."



Section 3: That Article X of the Lombard Traffic Code (Ordinance 1186) be amended by changing the language in section Q as follows:
