What does the Start the Heart Program involve and does my community need one?

SCA is one of the leading causes of death in the U.S., claiming the lives of over 300,000 people every year. CPR and the use of an AED can raise the survival rate for SCA up to 90%.

Start The Heart is unique because it combines many elements of proven life saving techniques into one program so that the community is prepared to save victims of SCA. Start the Heart educates community members on the steps of the "chain of survival" and gives municipalities the tools to implement this lifesaving program.

RESOLUTION RECOGNIZING THE VILLAGE OF LOMBARD AS A "START THE HEART COMMUNITY"

WHEREAS, sudden cardiac arrest is a leading cause of death in the United States and in DuPage County and is a major public safety issue; and

WHEREAS, sudden cardiac arrest takes the lives of more than 325,000 people in the United States each year and has a mortality rate of nearly 95 percent; and

WHEREAS, anyone can experience sudden cardiac arrest, including infants, high school athletes, and people in their 30s or 40s who have no sign of heart disease; and

WHEREAS, the use of lifesaving treatments such as Cardio Pulmonary Resuscitation (CPR) and automated external defibrillators (AED) for sudden cardiac arrest are effective if administered in time; and

WHEREAS, automated external defibrillators can increase the survival rate for sudden cardiac arrest up to 90 percent by delivering a life-saving shock within the first few minutes of an attack; and

WHEREAS, the Village of Lombard continues to proactively address issues of public safety; and

WHEREAS, the Village of Lombard is partnering with the DuPage County Health Department through the "Start The Heart Program" in order to recognize comprehensive efforts by offering to coordinate successful CPR training through Start the Heart, and public access to defibrillation campaign; therefore

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGEOFLOMBARD, DUPAGE COUNTY, ILLINOIS AS FOLLOWS:
