No Longer Conducting Business; Surrender of Liquor License

Rock Bottom Group, LLC notified Village Staff on August 1, 2023, that the licensee Rock Bottom Group LLC d/b/a Rock Bottom Restaurant and Brewery closed at the end of the business day on July 20, 2023 and is no longer conducting business at 94 Yorktown Shopping Center, Lombard, IL and is surrendering its Class "Z" liquor license.

ORDINANCE

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112,
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE TO REDUCE THE
NUMBER OF AVAILABLE LIQUOR LICENSES IN THE CLASS
“Z” LIQUOR LICENSE CATEGORY**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF
THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

SECTION 1: Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by decreasing the entries relative to the Class “Z” liquor licenses, contained therein, to read as follows:

Class “Z” – 0

SECTION 2: The decrease in the number of Class “Z” liquor licenses set forth in Section 1 above is a result of Rock Bottom Group, LLC d/b/a Rock Bottom Restaurant and Brewery, located at 94 Yorktown Shopping Center, Lombard, Illinois, no longer conducting business, and surrendering its Class “Z” liquor license.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
