

The treadmill for station #1 is a replacement of equipment. The treadmill is from Life Fitness 91Ti with heart rate. This is a commercial grade treadmill with 2 yr warranty on parts and one-year warranty on labor.

The Smith machine and Multi-gym are for station #2

- The Smith machine is a replacement for the bench-press machine. The Safety Committee has recommended the removal of the Bench press and to be replaced with a Smith machine.
- 10 year warranty on frame
- One-year warranty on parts, hardware, upholstery.

\*The multi-gym is in addition of equipment and also combining of equipment.

- On recommendation from the Fitness committee to make use of limited space at station #2
- 10-year warranty on frame
- One-year warranty on parts, hardware and upholstery

The President and Vice President of the 2% Committee has done a lot of research on the different styles and types of equipment, which vary widely. With help of the Safety-Committee and Fitness-Committee we have reached the conclusion that theses machines best meet the needs of the department.
