

## **ORDINANCE NO. 8054**

## AN ORDINANCE GRANTING A CONDITIONAL USE FOR OUTSIDE SERVICE AREAS PURSUANT TO TITLE 15, CHAPTER 155, SECTION 155.414(C)(19) OF THE LOMBARD ZONING ORDINANCE

PC 22-07; 236 E. St. Charles Road

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore adopted the Lombard Zoning Ordinance, otherwise known as Title 15, Chapter 155 of the Code of Lombard, Illinois; and,

WHEREAS, the Subject Property as defined below is zoned B2 Community Commercial District; and,

WHEREAS, an application has been filed requesting approval for a conditional use pursuant to Section 155.414(C)(19) of the Lombard Zoning Ordinance to allow for outside service areas (outdoor dining); and,

WHEREAS, a public hearing on the forgoing application was conducted by the Village of Lombard Plan Commission on April 18, 2022, pursuant to appropriate and legal notice; and,

WHEREAS, the Plan Commission has recommended the granting of the conditional use, subject to certain terms and conditions; and,

WHEREAS, the President and Board of Trustees of the Village of Lombard have determined that it is in the best interest of the Village of Lombard to approve the requested zoning actions herein by reference as if they were fully set forth herein;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

SECTION 1: That the following conditional use for outside service areas (outside dining) is hereby granted for the Subject Property legally described in Section 2 and subject to the conditions set forth in Section 3.

SECTION 2: That this Ordinance is limited and restricted to the property located at 236 E. St. Charles Road, Lombard, Illinois and legally described as follows:

LOT 10 IN BLOCK 14 IN H.O. STONE AND CO'S. ADDITION TO LOMBARD, BEING A SUBDIVISION OF PART OF THE SOUTHWEST QUARTER OF SECTION 5 AND PART OF THE NORTHWEST QUARTER OF SECTION 8, TOWNSHIP 39 NORTH, RANGE 11 EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED JUNE 26, 1924 AS DOCUMENT 179463, IN DUPAGE COUNTY, ILLINOIS.

SECTION 3: This ordinance shall be granted subject to compliance with the following conditions:

- 1. That the petitioner shall satisfactorily address all comments noted within the Inter-Departmental Review Committee Report.
- 2. The outdoor seating shall close by 10:30 PM Monday through Thursday; 11:30 PM Friday and Saturday; and 9:30 PM on Sunday.
- 3. This approval shall be subject to the commencement time provisions as set forth within Section 155.103(F)(11).

<u>SECTION 4:</u> This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.
