SUBJECT: Title XI, Chapter 112, Section 112.02 of the Lombard Village Code in regard to The Definition of Wine

It has come to the attention of staff regarding the fermentation of the contents of alcoholic beverages that creates wine, to clarify the definition of those that contain more than one half percent (0.5%) and not more than twenty-one percent (21%) alcohol by volume, e.g. "sake".

Attached is an ordinance amending Lombard Village Code Title XI, Chapter 112, Section 112.02 for the definition of "Wine". Village Code currently defines wine as follows:

Wine. Any alcoholic beverage obtained by the fermentation of the natural contents of fruits, or vegetables containing sugar, including such beverages when fortified by the addition of alcohol or spirits, as above defined.

The following includes the above as an amended definition of "Wine" of the Lombard Village Code to read as:

"Wine. Any alcoholic beverage obtained by the fermentation of the natural sugars of fruits or other agricultural products, containing more than one half percent (0.5%) and not more than twenty-one percent (21%) alcohol by volume, including such beverages when fortified by the addition of alcohol or spirits, as defined above."

AN ORDINANCE AMENDING TITLE XI, CHAPTER 112, SECTION 112.02 OF THE LOMBARD VILLAGE CODE IN REGARD TO THE DEFINITION OF WINE

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That the definition of "Wine" contained in Title XI, Chapter 112, Section 112.02 of the Lombard Village Code is amended to read in its entirety as follows:

"Wine. Any alcoholic beverage obtained by the fermentation of the natural sugars of fruits or other agricultural products, containing more than one half percent (0.5%) and not more than twenty-one percent (21%) alcohol by volume, including such beverages when fortified by the addition of alcohol or spirits, as defined above."

SECTION 2: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
