TEMPORARY EVENTS CODE AMENDMENT

As a companion to the other two ordinances relative to providing a new Class "P" overlay liquor license, attached is a draft ordinance amending Title 11, Chapter 110, Section 110.47(B) of the Lombard Village Code in regard to temporary events.

This amendment will provide for the ability to have more than four special event permits for a single parcel of property within the same calendar year if that entity holds a Class "P" liquor license for outdoor football events.

## AN ORDINANCE AMENDING TITLE 11, CHAPTER 110, SECTION 110.47(B) OF THE LOMBARD VILLAGE CODE IN REGARD TO TEMPORARY EVENTS

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 11, Chapter 110, Section 110.47(B) of the Lombard Village Code is amended by adding the following language to the end thereof:

"In the case of an entity which holds a Class "P" liquor license, a single permit shall be issued each year, covering the entire Chicago Bears football season, relative to the events held pursuant to the Class "P" liquor license during said Chicago Bears football season."
